Narrative:

On May 24, 2024, at approximately 0900 hours, Crime Scene Technician Emily Miller arrived at the Lucas County Coroner's Office to attend the autopsy of Beau Purtee. The office is located at 2595 Arlington Road, Toledo, Ohio 43614. The autopsy was performed by Coroner Dr. Jeffery Hudson with autopsy number 829.24.
