Narrative:

On July 22, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Nick Valente (Valente) began reviewing background information on Shannon Sloan (Sloan), the subject involved in the June 18, 2024, officer-involved shooting incident that occurred in Wadsworth, Ohio. The information reviewed included past police reports involving the subject and reviewing the subject's documented criminal history records. The information gathered was obtained from the BCI Criminal Intelligence Unit and the Wadsworth Police Department (WPD).

SA Valente reviewed all the information gathered and noted the following:

CCH:

Sloan did not have a CCH.

Prior Law Enforcement Contacts:

SA Eric Lehnhart (Lehnhart) requested WPD provide details regarding all previous encounters their agency had with Sloan. WPD provided police reports for eleven prior encounters the agency had with Sloan. SA Lehnhart received records and noted Sloan had multiple other encounters with law enforcement, to include traffic violations between 2006 and 2024.





FALSIFICATION Call Type Supplement Title: Hit / Skip Investigation On 8/17/17 I responded to the area of High Street near Walmart for a report of a hit skip crash. The suspect vehicle was leaving the area with the victim following it. The suspect vehicle was described as a jeep SUV with license plate GNGBEV3. The victim was asked to meet me at Fire Station #2. He described the driver as being a white female, in her 30s, with short blonde hair. She stopped immediately after the accident and got out of the car. When the victim advised he had to call for a police report, the suspect fled the scene in her vehicle. I contacted the suspect vehicle owner, by phone shortly after the accident. He did not know who would have his vehicle. I explained that the driver matched the description of his wife, but he didn't know why she would be in Wadsworth. He agreed to make some phone calls and call me back. I did not hear back from him. I called him back again and he advised he still hadn't figured out who had his car. ***** I called again on 8/19/17 and left a message. ***** On 8/20/17 I received a voicemail from advising that he wanted to talk to a lawyer before making contacting me back. ***** On 8/21/17 I received a voicemail from John Cameron, attorney for (330-722-8989). I called him back on 8/22/17. He explained that he would like to accompany when she talked to me. He agreed to call me tomorrow with a time to meet. He mentioned that it was his understanding that an "exotic dancer" who had been living with the stook the car. She has since moved out. I was unable to positively identify a suspect based on this very limited information and preliminary database searches.

On 9/14/17 I spoke with Margaret again. She provided a phone number for the suspect, She also advised that she would attempt to contact the to see if they had obtained any additional information. She didn't have any other information at the time. I did not hear back from Margaret that day.
I checked the given phone number through TLO but did not locate any matches.

I attempted to call the given number for on 9/17/17 but it rang busy.

As of 9/22/17 I still have not received information from the attorney's office that I had requested or even a call back. I called and left a voicemail asking for a return call. The suspect number I was provided continues to ring busy. Appolo Heating and Cooling called and left a voicemail asking for an update. I returned that call but was placed on hold and had to eventually disconnect.

On 9/23/17 I received a voicemail from He explained the situation. He advised that times are tough and his wife took a second job. At the job, she befriended the driver in this case, lost her home and needed a place to stay. Because has a suspended license, they allowed to live with them so Heidi could drive them to and from work. On the day of this incident, dropped off at work and took the car to 'run some errands.' beleives this is when the accident occurred. now doubts that this was her real name and advised the phone number they had for her has been disconnected. He offered to pay for the damages to the other vehicle.



FALSIFICATION Call Type Supplement Title: on the phone number gave me for her so I could ask her about the accident and to get her son's phone number so I could call and speak to him. She denied driving the Jeep that day and told me that her son would not know anything about the accident since he was not there. When I asked her how she would know that if she was not at the accident seen that day and then she hung up on me. A few days later Det. Schismenos and I went to Lusty's to speak to the owner Stan, to verify time at work on August 17th and to see if he has another employee named for him. Stan was not at Lusty's but I was able to speak to him by phone. he said that he does not know what time was at work on Aug. 17th but that she usually works from 1100 am until about 4 :00pm. He said it is very rare that she would be there past 5:00pm. He said that he is not familiar with anyone named but he would check his records and also check with his night bartender. He said that the bartenders sign the girls in and out. I spoke with the bartender currently working and she stated that she is not aware of any dancer by the name of working there. She said that when dancers apply to work there they have to show ID and that name she was not familiar with. She asked a couple other dancers who were currently working and they both said they did not know or a dancer matching that description. They advised that there are only about 4-6 dancers working at a time and the day shift girls do not work night shifts. One of the dancers, is a liar and she causes a lot of trouble there. She told me that some dancers use fake names but that all of them know each others real name, the fake names are for the customers. While there I was told that was currently working so I went to talk to her. She was on the phone with someone from the law firm that she said is representing her for her current OVI case. She said that she did not wish to speak to me without them present and handed me her phone. I spoke with a guy on the phone who said he works with John Cameron, who is an attorney and that John told to not talk to anyone until he gets back into town. I did tell me that did not work with her there but at her last place, Desiree's. I also noticed that had shoulder length blonde hair and not down to the middle of her back as stated. stated. also did not look like she does in her BMV photo. Her skin tone is lighter and she is thinner now than in the photo.
