Narrative:

On August 30, 2024, The Licking County Sheriff's Office (LCSO) requested the Ohio Bureau of Criminal Investigation (BCI) investigate an Officer-Involved Critical Incident (OICI) at 4206 Northridge Road, Alexandria, Ohio, involving officers with the LCSO, the Johnstown Police Department (JPD), and Doug Plott (Plott). Plott was ultimately shot by responding officers and succumbed to his injuries.

As a part of the investigation, SA Call requested the LCSO administrative staff for any previous calls for service involving Plott and/or the above address. SA Call was provided with one previous call for service from November 30, 2023.

The documentation indicates [REDACTED] came to the LCSO to obtain information and assistance with obtaining a protection order. The documentation indicates [REDACTED] reported [REDACTED] shoved her and threatened to kill her on the above date. The documentation describes [REDACTED] refusing to identify [REDACTED] and reiterating that she does not want press criminal charges against him. The report concluded indicating [REDACTED] was provided with the Ohio Victim's Rights Form and completed a written statement indicating she simply came to the LCSO to obtain options for her situation.

On 11-30-23 at 2027 hours, I met with [REDACTED] and Amy Riley in reference to a past physical domestic violence. I met [REDACTED] and Amy at 155 E Main St, where I let them inside the building to ask them about the incident.

[REDACTED] advised [REDACTED] shoved her earlier today and threatened to kill her. [REDACTED] wanted to meet with us to learn about CPO's and options for an eviction. When I explained all that to her I asked her about this report and needing to investigate the physical domestic violence [REDACTED] at this time refused to disclose information on [REDACTED] or fill out a Victims Rights packet.

Sgt. Hufford assisted me in attempting to get the information out of [REDACTED] still refused to give us the suspects name or location it occurred at [REDACTED] did inform me [REDACTED] with her and it appeared it occurred at their residence. However it was never disclosed word for word.

[REDACTED] filled out a Victim Rights Request Form with me. I cam scanned all three pages into my report and then gave [REDACTED] her packet. [REDACTED] then wrote a statement in her own words refusing to give us any information or want any charges.

I scanned both to my report and [REDACTED] cleared our office.
