sufficient to cover the obligations of the contract. A certificate of the Controlling Board shows that such board has released the money for this contract in accordance with section 8 of House Bill No. 531 of the regular session of the 91st General Assembly, and section 1 of Amended Senate Bill No. 401 of the first special session of the 91st General Assembly.

In addition, you have submitted a contract bond upon which the United States Fidelity and Guaranty Company of Baltimore, Maryland, appears as surety, sufficient to cover the amount of the contract.

You have further submitted evidence indicating that plans were properly prepared and approved, notice to bidders was properly given, bids tabulated as required by law, and the contract duly awarded. Also, it appears that the laws relating to the status of surety companies and the workmen's compensation act have been complied with.

Finding said contract and bond in proper legal form, I have this day noted my approval thereon, and return the same herewith to you, together with all other data submitted in this connection.
