Narrative:

On Monday, December 16, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Allison Fletcher (Fletcher) compiled background information on Charles Alexander (Alexander), a subject involved in the incident on November 11, 2024. The information included researching past police reports involving the subject, searching criminal history records, court records (if applicable), open/closed-source database inquiries, and social media posts. The information gathered was obtained from the BCI Criminal Intelligence Unit and the Ohio State Highway Patrol (OSHP).

SA Fletcher reviewed the information and noted the following:

Prior Police Encounters:

There were no documented prior police encounters with the OSHP.

Computerized Criminal History (CCH) and/or Court Records:



Database Searches:

An Accurint report was obtained and reviewed. Nothing relevant to the investigation was observed. The documents received relative to Alexander have been attached to this report for further review, except for any prohibited LEADS/CCH reports which were disposed of according to applicable policies and procedures.

Two social media accounts were located for Alexander, and they have been listed below:

Alexander's TikTok and Facebook appeared to have photos and videos of him and his daughter, Oaklynn Alexander (*Charles Alexander TikTok* and *Charlie Alexander FB*).

It appeared as though Alexander used his Facebook account in the hours and moments prior to the shooting incident. He posted statements to his Facebook page and also posted a video of himself and his daughter Oaklynn. The video was taken when Alexander was in the U-Haul truck threatening to kill himself and Oaklynn. During the video, Alexander made vague statements about killing Oaklynn and hoping Oaklynn's mother would have to live with regret because of it (*Charlie Alexander FB Post 1 – snip, Charlie Alexander FB post 2 – snip*, and *Charlie Alexander FB video snip*).

Additional posts to Facebook were reviewed that "friends" of Alexander posted. The posts made referenced Alexander and his actions. Some people defended his behavior, while others were critical.

There are SO many truths you don't know and as I am a private person I don't feel the need to share with you, but those of you saying the court system "left him no choice" ... shame on you & you have NO idealt

On one hand I appreciate that you're trying to give him the benefit of the doubt but I GUARANTEE had you lived in mine or Ashleys shoes in the last few months you would sing a different tune. Yes, right now Lam in the anger phase with him. Maybe that will pass, who knows.

A friend of mine died last night. His name is Charlie Alexander and he was 43 years old. His death was originally stated to be suicide but as more information is obtained it now appears he was shot by police after a standoff and a shootout, after he abducted his daughter and ran from pursing officers. Charlie has been going through a difficult high conflict divorce with a custody battle over their 7 year old daughter, and as per his final Facebook posts and a chilling and disturbing video he uploaded right before his death he talks about how she is being kept from him, and he refers to having already lost his other two children, who perished in a house fire some years ago. Unfortunately his daughter witnessed the shooting, and as per subsequent comments it apparently happened on her birthday, which is my birthday as well.

This hits very close to home as I too went through a high conflict divorce and was estranged from my 2 daughters for quite some time due to no fault of my own. Estrangement from your children by a soon to be ex spouse can be the most stressful event in a person's life. Charlie's daughter will carry scars from witnessing this horrible incident which will affect her and even her own children to some degree for many years to come.

Charlie I'm sorry you didn't get the chance to be the dad you so wanted to be, and that you probably didn't see my message and offer of assistance, along with those from so many of your friends, it's just a terrible tragedy that it had to go down this way.
