LEASE—RESERVOIR LAND, STATE WITH RICHARD R. RHINE, THOMAS C. RHINE AND WALLACE E. SNYDER, DESIGNATED PORTION, TURKEY FOOT LAKE, PORTAGE LAKES, SUMMIT COUNTY.

DEAR SIR: You have submitted for my examination and approval a certain reservoir land lease in triplicate, executed by the State of Ohio, through you as Commissioner of the Division of Conservation and Na-

tural Resources to Richard R. Rhine, Thomas C. Rhine and Wallace E. Snyder of Massillon, Ohio.

By this lease, which is one for a term of fifteen years and which provides for an annual rental of \$6.00, there is leased and demised to the lessees above named, permission to occupy and use for boathouse and docklanding purposes only, that portion of the State reservoir property that lies in front of the following described State reservoir property on Turkey Foot Lake, Portage Lakes: Beginning at a line drawn parallel to and six (6') feet northerly of the north line of Lot No. 7, Lakeview Terrace Allotment in Franklin Township, Summit County, as described in Plat Book No. 9, Page 13, Summit County Records, and extending thence in a northerly direction, 17 feet; said seventeen foot frontage lying in front of what is known as the "Commons" of the above mentioned allotment. The boathouse to be built hereon, is to be not more than 22 feet long, 13 feet wide, nor to extend higher than 5 feet higher than 5 feet above the standard water line of Turkey Foot Lake.

Upon examination of this lease, I find that the same has been properly executed by you as Commissioner of the Division of Conservation and Natural Resources and by said lessees. I further find, upon consideration of the provisions of this lease and of the conditions and restrictions therein contained, that the same are in conformity with Section 471, General Code, under the authority of which this lease is executed, and with other statutory enactments relating to leases of this kind.

I am accordingly approving this lease as to legality and form, as is evidenced by my approval endorsed upon the lease and upon the duplicate and triplicate copies thereof, all of which are herewith returned.
