
STATE OF OHIO'S MOTION FOR



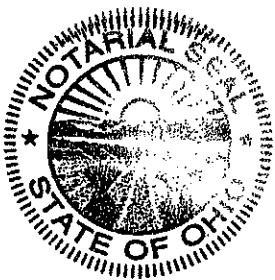

JUDGMENT ENTRY APPOINTING SPECIAL PROSECUTOR


