**Narrative:**

On January 1, 2022, the Ohio Bureau of Criminal Investigation (BCI) Crime Scene Unit (CSU) and Special Investigations Unit (SIU) responded to an officer-involved shooting which occurred at 2307 10<sup>th</sup> Street SW, Canton, Ohio, 44706. The shooting occurred in the city of Canton and involved a subject who had been transported to Aultman Hospital and a City of Canton Police officer.

Special Agent (SA) Matthew Armstrong (Armstrong) collected the involved officer's firearm from Canton Police Department Sgt. James Daniel. SA Charles Moran (Moran) collected evidence which belonged to the involved subject from Aultman Hospital.

At approximately 0713 hours, while at the crime scene, the items of evidence collected from Aultman Hospital and the evidence receipt were turned over to SA Armstrong by SA Moran.

At approximately 0725 hours, SA Armstrong cleared the scene and transported the items of evidence he collected from the police department and the items of evidence collected from Aultman Hospital to the BCI Richfield office located at 4055 Highlander Parkway, Richfield, Summit County, Ohio 44286. CSU SA Daniel Boerner (Boerner) transported the items of evidence collected from the crime scene. SA Armstrong met with SA Boerner at the BCI Richfield office, and there the items were secured in Temporary Evidence Storage Locker #30.
