Narrative:

On February 15, 2023, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Matt Armstrong (Armstrong) reviewed the following items related to the October 18, 2022, officer-involved critical incident which occurred at Southwest General Medical Center:

- Southwest General Police Department (SGPD) Computer Aided Dispatch (CAD) reports
- Audio recorded calls to police
- Audio recorded police radio traffic

The information was provided by SGPD Chief Tristan Harker (Harker) on February 9, 2023. Chief Harker informed SA Armstrong the Agency did not have mobile data terminals and therefore there were no MDT records to provide.

SA Armstrong reviewed the documents and recordings and noted the following:

SGPD CAD Report #'s 2230351; 2230354; 2230374

There were three SGPD CAD reports associated with this incident. They were identified with the following separate incident numbers: 2230351; 2230354; 2230374.

Incident 2230351:

The CAD report was generated on 10-18-2022 at 21:54:23 hours. The location was *EMERGENCY ROOM EX03* and the call type was *STAND BY INVEST*. Three officers of SGPD were dispatched at 21:54 hours and arrived at 21:55 hours. The CAD report was generated on 10-18-2022 at 22:50:39 hours. The location was *EMERGENCY ROOM EX03* and the call type was *STAND BY INVEST*. The call was generated by Sgt. (Unit and Officers and and were also assigned to the call. All three were shown on scene at 22:50 hours.

The CAD report was generated on 10-19-2022 at 03:22:16 hours. The location was *NECROPSY* and the call type was *BODY RELEASE*. Sgt. Officer and Officer and Officer and were assigned to the call. Sgt. was on scene at 03:23 hours and Officers and were on scene at 03:26 hours. All three officers cleared at 03:36 hours.

Coroners case Released by Unit 29 and 32 10/19/2022 13:48:01 Disp 56

It appeared Unit 29 and Unit 32 released the body to the coroner's office. They were identified with the roster as Officers Michael Doctor (Unit 29) and Andy Rodenhauser (Unit 32).

Audio recorded Calls to Police

There were two calls made to the police department by staff in the Emergency Department. The audio recordings were titled 22006401 and 22006402. There was no date or time associated with the recordings. SA Armstrong reviewed each recording and noted the following:

<u>22006401</u>:

The recording was 22 seconds. A female dispatcher answered the call and a female voice stated "Hey umm, can we have you guy the guys over here for room three, he's pink slipped and he's acting up." The dispatcher asked what the subject was doing and the caller said: "I don't know they just told me to call you." The dispatcher said "Ok" and the recording ended.

<u>22006402</u>:

The recording was 23 seconds. When the recording began, a female dispatcher can be heard dispatching officers to Exam Room 3 in the Emergency Department. A male voice can be heard screaming in the background. After dispatching the officers, the dispatcher said "Southwest Police Department." A female voice then said "Hi. I need police to exam room 3 in the ED." The dispatcher indicated they had received a call for it and asked what was going on. The female caller then said: "A patient's getting physically aggressive with staff." The dispatcher said "Ok" and the recording ended.

Audio Recorded Police Radio Traffic

The radio traffic provided included the following six individually recorded radio transmissions.

SA Armstrong reviewed each recording and determined there was no date or time associated with the recorded radio transmissions. Most of the transmissions were unintelligible. The following information was noted:

Recording 22006403:

A female dispatched officers to the emergency room stating: "Radio to Units. I need you in the ER for Exam 3, pink slipped, acting out." Three units acknowledge the dispatch and then the dispatcher stated "Units be advised, second call, he's becoming physically aggressive with staff."

<u>Recording 22006404</u>:

An unidentified unit radioed "I'm Here."

<u>Recording 22006407</u>:

Unit radioed "Out of four point at [unintelligible]."

<u>22006408</u>:

The dispatcher asked about the four point. A male unit responded "Taken out at 2205."
