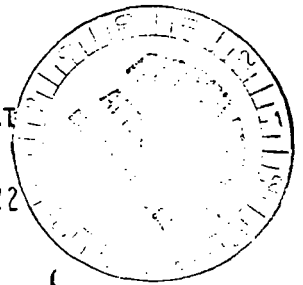

CONSENT ORDER

The complaint in the above-captioned case was filed with this Court on November 19, 1984. The plaintiff State of Ohio, by its Attorney General, Anthony J. Celebrezze, Jr., and defendants Cavendish Petroleum of Ohio Inc. and Dynamic Drilling, Inc. consent to this decree without any admission of liability on the part of either defendant for any of the alleged violations contained in the complaint.

NOW, THEREFORE, without trial or adjudication of any issue of law or fact arising from the complaint, and before the taking of any testimony, but upon the consent of the parties hereto, this Court hereby ORDERS and DECREES as follows:

I

This Court has jurisdiction over the subject matter herein and the parties consenting hereto. The complaint states a claim upon which relief can be granted to the plaintiff against defendants Cavendish Petroleum of Ohio Inc. and Dynamic Drilling, Inc. under Chapter 1509 of the Ohio Revised Code.

II

The provisions of this Consent Order apply to and are binding upon defendants Cavendish Petroleum of Ohio Inc. and Dynamic Drilling, Inc.,


their officers, directors or successors.

III

Defendants Cavendish Petroleum of Ohio Inc. and Dynamic Drilling, Inc. shall pay to plaintiff State of Ohio the amount of four thousand dollars (\$4,000.00) not later than ten days after the entry of this consent order. Payment shall be made by delivering to plaintiff's counsel a certified check in such amount made payable to "Treasurer, State of Ohio." Such payment shall be in full satisfaction of any liability of defendants Cavendish Petroleum of Ohio Inc. and Dynamic Drilling, Inc. for all violations asserted in the complaint.

IV

Defendants Cavendish Petroleum of Ohio Inc. and Dynamic Drilling, Inc. shall pay any court costs attributable to the claims asserted against them in the complaint.
