The State of Ohio by its Attorney General, Lee Fisher, filed a Complaint seeking injunctive relief and a civil penalty for Defendant's alleged violations of Ohio Revised Code Chapter 3704 and the rules adopted thereunder. The parties, with regard to these issues, have reached an agreement as to the payment of a civil penalty. Therefore, without trial of any issues of law or fact, without admission or denial of any allegation in the complaint, and upon consent of the parties, it is hereby ORDERED, ADJUDGED and DECREED as follows:

I. JURISDICTION AND VENUE

1. This Court has jurisdiction over the subject matter herein pursuant to Chapter 3704 of the Revised Code of Ohio. The Court has jurisdiction over the parties hereto. The Complaint states claim upon which relief can be granted. Venue is proper in this Court.

II. PERSONS BOUND

2. The provision of this Order shall apply to and be binding upon the parties to this action, their agents, officers, employees, assigns and successors in interest.

III. SATISFACTION OF LAWSUIT

3. Compliance with the terms of this order shall constitute full satisfaction of any civil liability of Defendant D. L. Auld Company dba 3M Auld for the violations of Ohio Revised Code ("O.R.C.") Chapter 3704 and the regulations thereunder alleged in the Complaint.

4. This Order does not limit the authority of the State of Ohio to seek relief for any claim not alleged in the Complaint, including claims not known at this time, or future violations of O.R.C. Chapter 3704 and the regulations thereunder occurring after the filing of this Consent Order.

IV. CIVIL PENALTIES

5. Defendant D. L. Auld Company shall pay the State of Ohio a civil penalty of one hundred thousand dollars (\$100,000.00). The penalty shall be paid by delivering a certified check for said amount made payable to the order of "Treasurer, State of Ohio" to Matthew A. Sanders, Acting Administrative Assistant, or a person subsequently designated by the State, at the office of Attorney General Environmental Enforcement, 30 East Broad Street, 25th Floor, Columbus, Ohio

V. RETENTION OF JURISDICTION

6. This Court will retain jurisdiction of the action for the purpose of enforcing this Consent Order.

VI. COURT COSTS

7. Defendant D. L. Auld Company is ordered and enjoined to pay any court costs and fees of this action.


VII. ENFORCEMENT COSTS

8. Defendant D. L. Auld Company is ordered and enjoined to pay the enforcement costs relator Ohio Attorney General expended in pursuing this action, totalling five thousand dollars (\$5,000.00) by delivering a certified check in such an amount for payment into the State's Treasury made payable to the order to "Treasurer, State of Ohio" to Matthew A. Sanders, Acting Administrative Assistant, or a person subsequently designated by the State, at the office of the Attorney General of Ohio, Environmental Enforcement, 30 East Broad Street, 25th Floor, Columbus, Ohio 43215-3428, within thirty (30) days after the entry of this Consent Order. Any check submitted in compliance with this Section shall be in addition to and separate from any check submitted pursuant to any other Section of this Consent Order.




