JUDGMENT

This action came on for trial before the Court, and the issues having been duly tried and a decision having been duly rendered, it is hereby ORDERED and ADJUDGED that:

A) Defendant Hanley Hardin is enjoined for a period of one year from the date of the entry of this judgment from violating the provisions of R.C. Chapter 1509, and orders issued and rules adopted thereunder within Meigs County, Ohio;


B) Defendant Hanley Hardin shall pay a civil penalty in the amount of ten-thousand dollars, five-thousand of which is SUSPENDED upon the condition that Defendant Hardin not violate any of the provisions of R.C. Chapter 1509 and orders issued and rules adopted thereunder within Meigs County, Ohio for a period of one year after entry of this order. Payment of the five-thousand dollars shall be made by delivering to the Fiscal Section, Division of Oil and Gas, Fountain Square, Building A., Columbus, Ohio, 43224, within thirty days after entry of this judgment, a certified check in such amount made to the order of "Treasurer, State of Ohio".

C) The third-party complaint as against Defendant Akron Oil Corporation is dismissed with prejudice; and

D) Defendant Hardin shall pay court costs.


