This matter comes before the Court upon the motion of Tuenté Farms, Inc.

and Tuenté Livestock Inc., to terminate this Court's Consent Order of January 15, 1988. In 1993 Tuenté Farms, Inc. acquired from Defendant A.J. DeCoster. the real estate and facility where Defendant Shelbco Inc. operated. The operation of this real estate and facility is subject to the terms of a Consent Order entered by the Court in the above-captioned matter on January 15, 1988. Under the terms of the Consent Order Tuenté Farms, Inc. and Tuenté Livestock, Inc., as successors in interest to Shelbco, Inc., are required to comply with the injunctive provisions of the order.

However, Tuenté Farms, Inc. and Tuenté Livestock, Inc. have subsequently developed and submitted an animal waste management plan for the operation of this facility to Ohio EPA. Ohio EPA has approved that plan and the operation of the facility in the future will be governed by the terms of that plan as approved.

Therefore the parties have agreed that this Court's Consent Order of January 15, 1988 should be terminated.

NOW THEREFORE, it is hereby ORDERED that this Court's Order entered


January 15, 1988 is terminated as of the filing of this entry. The clerk of this court shall cause copies of this judgment entry to be mailed to counsel of record in this matter.
