This matter is before the Court on Appellee Director, Ohio Department of Jobs and Family Services' December 7, 2011 Motion to Dismiss pursuant to R.C. 4141.282. This matter is properly before the Court.

I. BACKGROUND

This matter began when Ciara Peoples ("Appellant") received an unfavorable decision from the Ohio Unemployment Compensation Review Commission ("Review Commission"). On August 15, 2011, the Review Commission issued its Decision finding that the Appellant was discharged for just cause. On September 14, 2011, the Review Commission disallowed the Appellant's request for review.

The Appellant timely filed a Notice of Appeal on October 17, 2011 however; the Notice of Appeal was legally insufficient for the reasons discussed below.

II. DISCUSSION

The Court is bound by the *mandatory* language of R.C. 4141.282(A) and 4141.282(D) regarding the procedural aspects of Appellant's appeal.

R.C. 4141.282(A) states "Any interested party, within thirty days after written notice of the final decision of the unemployment compensation review commission was sent to all interested parties, may appeal the decision of the commission to the court of common pleas."

R.C. 4141.282(D) states "The commission shall provide on its final decision the names and addresses of all interested parties. The appellant *shall* name all interested parties as appellees in the notice of appeal. *The director of job and family services is always an interested party and shall be named* as an appellee in the notice of appeal."² (emphasis added).

In Appellant's Notice of Appeal, Appellant failed to name the Director of the Ohio Department of Job and Family Services as a party to this action. Further, the law does not permit the Appellant now to amend the notice of appeal since the deadline to file the same has passed.³

A recent 11th District Court of Appeals decision citing controlling case law from the Ohio Supreme Court holds that the party (such as Appellant) appealing the Review Commission's final decision must *strictly comply* with R.C. 4141.282(D)'s requirement of

naming all interested parties as appellees.⁴ And this Appellant did not do, thereby denying this Court jurisdiction to hear this matter.⁵

III. **DECISION**

This appeal is DISMISSED. The Appellant's Notice of Appeal fails to name the Director of the Ohio Department of Job and Family Services. This Court lacks subject matter jurisdiction in this appeal.
