This matter is before the Court on Appellee Ohio Unemployment Compensation Review Commission's ("Review Commission") Motion to Dismiss Appellant's Civil Appeal, Appellant Rosa Response to Motion to Dismiss and Appellee's Reply thereto. Also before the Court is Appellant's Motion to Amend Appeal.

The Court has considered the briefs in support and in opposition, as well as all pertinent pleadings. For the reasons stated in Appellee's Motion and Reply, the Court finds the Motion well-taken. R.C. §4141.282(A) provides that any interested party may appeal the decision of the unemployment compensation review commission to the court of common pleas within thirty days after written notice of the final decision of the commission was sent to all interested parties. R.C. §4141.282(D) further provides that the director of job and family services ("ODJFS") "shall be named as an appellee in the notice of appeal." It is well

established that "where a statute confers a right of appeal, ... strict adherence to the statutory conditions is essential for the enjoyment of that right." Appellant failed to name the director of ODJFS in her notice of appeal. Moreover, the 30-day statutory period for filing an appeal of the Review Commission's decision expired on December 10, 2012. Thus, any amended notice of appeal filed at this point would be untimely. Accordingly, Appellee's Motion to Dismiss is GRANTED and Appellant's Motion to Amend Appeal is DENIED. Appellant's Notice of Appeal is therefore dismissed.

There is no just cause for delay.
