This case came on for consideration as a statutory unemployment appeal filed by Appellant Alexander Stephen (Stephen) on September 28, 2012 under R.C. 4141.282. Stephen appeals from the final *Decision* of the Unemployment Compensation Review Commission (UCRC) dated August 30, 2012 that denied his claim for unemployment benefits on the basis that he quit his employment at Bruce G. Obenour, d.b.a. Wendy's, without just cause under R.C. 4141.29(D)(2)(a) and held that he was overpaid unemployment benefits pursuant to R.C. 4141.35(A).

After due consideration, the Court hereby affirms and modifies the *Decision* of the UCRC as follows. Specifically, the Court hereby affirms the *Decision* of the UCRC that Stephen quit his employment at Wendy's without just cause under R.C. 4141.29(D)(2)(a). However, the Court hereby modifies the *Decision* of the UCRC and finds that Stephen was overpaid unemployment benefits by ODJFS for reasons other than fraudulent misrepresentation under R.C. 4141.35(B).

Finally, the Court hereby modifies the *Decision* of the UCRC and ORDERS that no further penalty weeks or ineligibility period shall be imposed against Stephen with respect to this decision that he was overpaid unemployment benefits for reasons other than fraudulent misrepresentation under R.C. 4141.35(B). Final judgment is hereby granted in favor of Appellee, Ohio Department of Job and Family Services. Costs to Appellant.
