12/19/2012 REVIEW OF SURVEILLANCE CD OF VA HOSPITAL

Summary

On December 19, 2012, SA Moore reviewed a Compact Disk (CD) containing surveillance footage related to the police involved shooting regarding the subjects Timothy Russell and Malissa Williams. SA Moore observed in the video surveillance named WADE PARK AND 105 EAST BOUND what appeared to be one (1) subject vehicle followed by thirty (30) police cruisers. SA Moore observed in the video surveillance named WADE PARK AND 105 N BOUND what appeared to be one (1) subject vehicle followed by thirty one (31) police cruisers. SA Moore observed in the video surveillance named WADE PARK and 105 W BOUND what appeared to be one (1) subject vehicle followed by thirty one (31) police cruisers.

Details

WADE PARK AND 105 EAST BOUND: This video is 00:05:12 in length.

Approximately 00:00:28 into the footage, what appears to be a police cruiser enters the frame traveling in the direction from the right to the left of the frame. The date and time stamp in the corner of the video displays 11/29/2012 10:44:36 PM(GMT-5:00). Approximately 00:00:50 into the footage, the police cruiser exits the frame. The date and time stamp in the corner of the video displays 11/29/2012 10:44:58 PM(GMT-5:00).

Approximately 00:01:27 into the footage, what appears to be the suspect vehicle enters the frame traveling in the direction from the left to the right of the frame. The date and time stamp in the corner of the video displays 11/29/2012 10:46:18 PM(GMT-5:00). The first police cruiser enters the frame and appears to be approximately two car lengths behind the suspect vehicle. What appear to be an additional twenty three (23) cruisers are observed following the suspect car and lead cruiser.

Approximately 00:02:44 into the footage, what appears to be a red Sport Utility Vehicle (SUV) enters the frame traveling in the direction from the left to the right of the frame at a slower rate of speed. The date and time stamp in the corner of the video displays 11/29/2012 10:47:36 PM(GMT-5:00).

Approximately 00:03:00 into the footage, another police cruiser enters the frame traveling in the direction from the left to the right of the frame. The date and time stamp in the corner of the video displays 11/29/2012 10:47:52 PM (GMT-5:00). An additional five (5) police cruisers are observed behind this cruiser. The last cruiser exits the frame at approximately 11/29/2012 10:48:09 PM(GMT-5:00).

WADE PARK AND 105 N BOUND: This video is 00:06:33 in length.

Approximately 00:00:56 into the footage, a police cruiser is observed traveling from the right of the frame to the left of the frame, turning right at an intersection. The date and time stamp in the corner of the video displays 11/29/2012 10:45:01 PM(GMT-5:00).

Approximately 00:01:52 into the footage, what appears to be the suspect vehicle enters the frame and crosses the intersection, traveling from the left to the right of the frame. The date and time stamp in the corner of the video displays 11/29/2012 10:46:17 PM(GMT-5:00). The first police cruiser enters the frame and appears to be approximately one car length behind the suspect vehicle. What appear to be an additional twenty two (22) cruisers are observed following the suspect vehicle and lead police cruiser. Approximately 02:28 into the footage, one of these police cruisers pauses in the intersection to allow two police cruisers to pass in front of it. Two (2) vehicles are observed waiting at the stop light at the intersection.

Approximately 00:02:36 into the footage, a vehicle is observed crossing the intersection.

Approximately 00:02:53 into the footage, a twenty fourth police cruiser is observed traveling from the left to the right of the frame, turning right into the intersection and not following the direction of the pursuit. The date and time stamp in the corner of the video displays 11/29/2012 10:47:18 PM(GMT-5:00). Approximately 00:02:56 into the footage, a twenty fifth police cruiser is observed traveling from the left to the right of the frame, following the direction of the pursuit.

Approximately 00:03:20 into the footage, a twenty sixth police cruiser is observed traveling from the left to the right of the frame, following the direction of the pursuit. The date and time stamp in the corner of the video displays 11/29/2012 10:47:45 PM(GMT-5:00). This police cruiser

pauses in the intersection, while five additional police cruisers follow the direction of the pursuit. After the five police cruisers pass through the intersection, police cruiser twenty six joins in the direction of the pursuit. The police cruiser exits the frame approximately 00:03:39. The date and time stamp in the corner of the video displays 11/29/2012 10:48:04 PM(GMT-5:00).

Approximately 00:04:13 into the footage, the video errors and a message is displayed that the media player encountered a problem while playing the file.

WADE PARK AND 105 W BOUND: This video is 00:06:37 in length.

Approximately 00:00:56 into the footage, a police cruiser enters the frame from the lower right-hand corner, travels into the intersection, and turns right. The date and time stamp in the corner of the video displays 11/29/2012 10:44:57 PM(GMT-5:00).

Approximately 00:01:52 into the footage, what appears to be the suspect vehicle enters the frame from the upper left, travels into the intersection, and proceeds to go straight, exiting the frame in the lower right corner. The date and time stamp in the corner of the video displays 11/29/2012 10:46:17 PM(GMT-5:00).

The suspect vehicle appears to be pursued by twenty three (23) police cruisers. Approximately 00:02:55 into the footage, a twenty fourth police cruiser turns left into the intersection and does not follow the direction of the pursuit. The date and time stamp in the corner of the video displays 11/29/2012 10:47:20 PM(GMT-5:00).

An additional seven police cruisers travel in the direction of the pursuit, with the last police cruiser exiting the frame approximately 00:03:41 into the footage. The date and time stamp in the corner of the video displays 11/29/2012 10:48:06 PM(GMT-5:00).
