**12/20/12      REVIEW 205 WEST ST. CLAIR STREET VIDEO RECORDING**

**Summary**

On December 20, 2012 S/A Brenda McNeely reviewed 2 video recordings titled 205 West St. Clair St. "Cleveland Police Department and 205 W. St. Clair St. evidence item #14 from S/A Rick Warner #135. This video depicted the marked cruiser in front of the building initiating a pursuit with a vehicle traveling southwest on West St. Clair St.

**Details**

The video recording marked evidence #14 in case CC-12-03-0116 appeared to be an exact replica of the video recording marked "City of Cleveland". They both appeared to be from the same exact time frame on the same date and from the same camera view. It was of the external front of 205 West St. Clair Street and was provided by the City of Cleveland. The recording was from November 29, 2012 at 22:14:59:234 hours until 23:14:59:953.

A Cleveland Police Department marked police unit enters the camera viewing screen at 22:31:01:593 from the left (southwest) and parallel parks in front of 205 West St. Clair Street. The officer driving the vehicle exits the vehicle at 22:33:44:500 hours and walks towards the sidewalk in front of the building. Someone exits 205 West St. Clair Street approximately 2 seconds later and approaches the officer who, after a short time, opens the trunk of his vehicle.

A vehicle consistent with a 1979 Chevrolet Malibu, and later learned to be occupied by Timothy Russell and Malissa Williams, is observed entering the camera's viewing area at 22:34:13:671 hours, moving from right to left, which is actually northeast to southwest on West St. Clair Street. The vehicle passes the police unit approximately 3 seconds later and continues southwest, exiting the camera viewing area at 22:34:17:937 hours.

The police officer quickly rushes to his vehicle and pursues after the vehicle approximately 10 seconds later. The person the officer was interacting with in front of the building quickly enters 205 West St. Clair Street.

Someone is observed exiting 205 W. St. Clair Street at 22:43:38:984 hours and he runs across the street to the Justice Center, in the area of the parking garage. Approximately 2 minutes later, a marked police unit is observed exiting the garage and traveling southwest.

Less than a minute after, two marked police units are observed traveling northeast on West St. Clair St. from a southwest direction with their emergency lights activated, entering the camera's viewing area at 22:46:04:062. One more police unit is seen exiting the parking garage area at 22:52:09:625 hours and proceeds to travel northeast but does not have any emergency lights activated as of the time it exits the camera's viewing area.
