12/21/2012 REVIEW OF AUTOMATED VEHICLE LOCATOR (AVL)

Summary

Special Agent Richard Warner reviewed Automated Vehicle Locator (AVL) of Cleveland Police cars that were involved in a pursuit and subsequent officer involved shooting that occurred in East Cleveland on November 29, 2012.

Details

SA Warner was provided a DVD containing video files that displays the route Cleveland Police vehicles traveled during the course of the pursuit on November 29, 2012. The following is a summary of times and locations of the CPD units.

CPD Unit 146 – Occupied by UNKNOWN OFFICERS

Unit 146 is first observed in the area of Lorain Ave. and W. 150th St. traveling e/b on Lorain Ave.

Unit 146 travels to the area of the pursuit route but remains in the area of Lorain Ave. and Dennison

CPD Unit 212A – Occupied by Officers O'Malley #524 and Esson #1752

Unit 212A is observed entering the pursuit route in the area of Lorain Ave. and W. 65th St. at 2237hrs.

Unit 212A travels the pursuit route to Lee Blvd in East Cleveland and proceeds on Lee Blvd South to Forest Hills Blvd west to Terrace Road eastbound arriving in the area of Heritage Middle School at 2257hrs.

CPD Unit 215 – Occupied by Officers Wilfredo Diaz #350 and Dymphna O'Neill #1503

Unit 215 is observed entering the pursuit route in the area of Lorain Ave. and W. 85th St. at 2237hrs.

Unit 215 travels the pursuit route to Wymore Ave arriving at Heritage Middle School at 2254hrs.

CPD Unit 217 – Occupied by Officers Cynthia Moore #1277 and Mike Brelo #416

Unit 217 is first observed entering the pursuit route in the area of Superior Ave. and Detroit Ave. at 2234hrs.

Unit 217 travels the pursuit route to Wymore Ave. arriving at Heritage Middle School at 2254hrs.

CPD Unit 221A – Occupied by UNKNOWN OFFICERS

Unit 221A is first observed entering the pursuit route in the area of W. 14th St. and I-90 e/b.

Unit 221A travels the pursuit route to E. 72nd St. and then deviates from the route till reaching Euclid Ave. where Unit 221A resumes the pursuit route to just east of E 123rd St. and Euclid Ave. at 2254hrs.

Unit 221A does not travel to Heritage Middle School.

CPD Unit 223 – Occupied by UNKNOWN OFFICERS

Unit 223 is first observed entering the pursuit route in the area of I 71 n/b and I-90 e/b.

Unit 223 does not travel the pursuit route to Heritage Middle School; however, Unit 223 is observed in the area of Lee Blvd near Terrace Rd. at 2303hrs.

CPD Unit 224A – Occupied by UNKNOWN OFFICERS

Unit 224A is first observed entering the pursuit route in the area of W. 85th St. and Clark Ave.

Unit 224A does not follow the pursuit route until Wade Park Ave.

Unit 224A arrives at Heritage Middle School at 2254hrs.

CPD Unit 224L- Occupied by Officer Nan #2310

Unit 224L is observed in the area between W. 3rd St. and Ontario St. on St. Clair Ave. at 2232hrs.

Unit 224L enters the pursuit in the area of W. 73rd St. and Clark Ave.

Unit 224L follows the pursuit path to Lee Blvd. heading s/b on Lee to Private Dr.

Unit 224L turns around heading back n/b on Lee Blvd stopping in the area east of Heritage Middle School at 2255hrs.

CPD Unit 226 – Occupied by Officer Mathias Varga #302

Unit 226 is observed first entering the pursuit route on W. 14th St. near I-90 e/b.

Unit 226 follows the pursuit path until E. 72nd St. then resuming the pursuit route from Superior Ave. at Euclid Ave.

Unit 226 continues the pursuit route on to Wymore Ave. at 2256hrs.

CPD Unit 227 – Occupied by Officer Michael McNeeley #1925

Unit 227 is observed first entering the pursuit route Detroit Ave. at W. 45th St.

Unit 227 continues the pursuit route to Wymore Ave. into Heritage Middle School arriving at 2254hrs.

CPD Unit 232 – Occupied by Officers Brian Sabolik #1021 and Mike Farley #409

Unit 232 is observed first entering the pursuit route at W. 14th St. at Starkweather.

Unit 232 follows the pursuit route to Wymore Ave. arriving at Heritage Middle School at 2255hrs.

CPD Unit 233 – Occupied by Officers Ivancic #2115 and Torres #10

Unit 233 is observed first entering the pursuit route at E. 118th St. at Euclid Ave.

Unit 233 follows the pursuit route to Wymore Ave. north of Terrace Rd. arriving at 2256hrs.

CPD Unit 234 – Occupied by Officers Wagner #2270 and Bresnahan #313

Unit 234 is observed first entering the pursuit route from I-90 e/b at W.14th St.

Unit 234 follows the pursuit route to E. 55th St.

Unit 234 arrives in the area of Heritage Middle School parked on Wymore Ave. at 2258hrs.

CPD Unit 235 – Occupied by UNKNOWN OFFICERS

Unit 235 does not enter the pursuit route and does not travel to the area of Heritage Middle School.

CPD Unit 236 – Occupied by Officers Katynski #1199 and Cruz #772

Unit 236 is observed entering the pursuit route at W. 73rd and Clark Ave.

Unit 236 continues the pursuit route or shadowing the pursuit route to Terrace Rd. arriving in the area of Heritage Middle School at 2256hrs.

CPD Unit 238 – Occupied by Officers Scott Sitek #1395 and Robert Radosevic #2396

Unit 238 is observed entering the pursuit route at W. 44th St. and Lorain Ave.

Unit 238 continues the pursuit route to Wymore Ave. arriving at Heritage Middle School at 2254hrs.

CPD Unit 244 – Occupied by Officers Jaime Cruz #2466 and Tony Gonzalez #112

Unit 244 is observed entering the pursuit route at Fulton Rd. and Clark Ave.

Unit 244 continues the pursuit route to Wymore Ave. arriving at Heritage Middle School at 2254hrs.

CPD Unit 284 – Occupied by UNKNOWN OFFICERS

Unit 284 is observed entering the pursuit route at W. 25th and Detroit Ave.

Unit 284 continues the pursuit route to I 90 e/b and St. Clair Ave.

Unit 301 is observed entering the pursuit route at Euclid Ave. and E. 118th St. at 2256hrs.

Unit 301 travels the pursuit route to Wymore Ave. arriving at 2300hrs.

CPD Unit 306 – Occupied by Officers Smith #816 and Price #2339

Unit 306 is observed entering the pursuit route at E 71st and Addison Rd.

Unit 306 shadows the pursuit route to Lee Blvd. arriving in the area of Heritage Middle School at 2255hrs.

CPD Unit 309 – Occupied by UNKNOWN OFFICERS

Unit 309 is observed entering the pursuit route E. 79th and Decker.

Unit 309 shadows the pursuit route to Wymore Ave. arriving at 2259hrs.

Unit 309 does not enter the area of Heritage Middle School and travels w/b on Euclid Ave.

CPD Unit 312 – Occupied by Officers Aldridge #280 and Brown #637

Unit 312 is observed entering the pursuit route at E. 79th and Wade Park Ave. and shadows the pursuit route to Terrace Rd. arriving in the area of Heritage Middle School at 2257hrs.

CPD Unit 316 – Occupied by Officers Schneider #1797 and Johnson #60

Unit 316 is observed entering the pursuit route at Wade Park Ave and E 79th St.

Unit 316 travels the pursuit route to Terrace Rd. and Wymore Ave. arriving in the area of Heritage Middle School at 2255hrs.

CPD Unit 324 – Occupied by Officer Koney #744

Unit 324 is observed entering the pursuit route at E. 79th St. and Wade Park Ave.

Unit 324 travels the pursuit route to Wymore Ave. and Heritage Middle School arriving at 2255hrs.

CPD Unit 324A – Occupied by UNKNOWN OFFICERS

Unit 324A does not travel the pursuit route and does not arrive at or around Heritage Middle School.

CPD Unit 326 – Occupied by Officers Mateo #1008 and Rescina #314

Unit 326 is observed entering the pursuit route at Addison Ave. and Star Ave.

Unit 326 travels the pursuit route to Wymore Ave. arriving at Heritage Middle School at 2254hrs.

CPD Unit 327 – Occupied by Officers Ryan #606 and Alderman #831

Unit 327 is observed entering the pursuit route at East Ave. and Wade Park Ave.

Unit 327 shadows the pursuit route to Wymore Ave. near Terrace Rd. arriving at 2257hrs.

CPD Unit 334 – Occupied by Officers Frinzl #267 and Gorzelanczyk #1555

Unit 334 is observed entering the pursuit route SR 2 e/b and I 90 e/b.

Unit 334 shadows the pursuit arriving at Wymore Ave. and Heritage Middle School at 2255hrs.

CPD Unit 343 – Occupied by Officers Hayduk #349 and Makad #1570

Unit 343 is observed entering the pursuit route at Prospect Ave. and I 90 e/b.

Unit 343 shadows the pursuit route to Lee Blvd to the area of Heritage Middle School arriving at 2255hrs.

CPD Unit 352 – Occupied by UNKNOWN OFFICERS

Unit 352 does not leave the area of 3rd District Headquarters.

CPD Unit 355 – Occupied by UNKNOWN OFFICERS

Unit 355 is observed entering the pursuit route at E. 85th St. and Wade Park Ave.

Unit 355 travels the pursuit route to Wymore Ave. near Terrace Rd. arriving at 2259hrs.

CPD Unit 357 – Occupied by UNKNOWN OFFICERS

Unit 357 is observed entering the pursuit route at E. 79th St. and Wade Park Ave.

Unit 357 travels the pursuit route to Wymore Ave. and Terrace Rd. arriving at 2255hrs.

CPD Unit 369 – Occupied by UNKNOWN OFFICERS

Unit 369 is observed entering the pursuit route at Euclid Ave. and E. 118th St.

Unit 369 travels the pursuit route to Lee Blvd in the area of Heritage Middle School arriving at 2259hrs.

CPD Unit 388 – Occupied by Officer Christopher Ereg #767 and Sgt. Putnam #9081

Unit 388 is observed entering the pursuit route at E. 71st and Addison Rd.

Unit 388 travels the pursuit route to Lee Blvd. across into Heritage Middle School arriving at 2254hrs.

CPD Unit 503 – Occupied by UNKNOWN OFFICERS

Unit 503 is observed entering the pursuit I-90 w/b at E. 72nd St.

Unit 503 shadows the pursuit route to Terrace Rd. traveling s/b on Wymore Ave. into Heritage Middle School arriving at 2255hrs.

CPD Unit 511 – Occupied by Officers O'Neill #1584 and Claudio #1563

Unit 511 is observed entering the pursuit S. Marginal Rd. and I-90 e/b.

Unit 511 shadows the pursuit route arriving at Terrace Rd. and the area of Heritage Middle School at 2258hrs.

CPD Unit 511B – Occupied by Officer Valentino #2546

Unit 511B is observed entering the pursuit route at Superior Ave. and Euclid Ave.

Unit 511B travels the pursuit route to Terrace Rd. and the area of Heritage Middle School at 2255hrs.

CPD Unit 512 – Occupied by UNKNOWN OFFICERS

Unit 512 does not follow the pursuit route.

Unit 512 does not arrive in the area of Heritage Middle School.

CPD Unit 512A – Occupied by Officer Schlacht #2378 and Longer #2452

Unit 512A is observed entering the pursuit route at Superior Ave. and Euclid Ave.

Unit 512A travels the pursuit route to Wymore Ave. near Terrace Rd. arriving at 2258hrs.

CPD Unit 516 – Occupied by UNKNOWN OFFICERS

Unit 516 is observed entering the pursuit route at Superior Ave. and Euclid Ave.

Unit 516 travels the pursuit route to Wymore Ave. and Terrace Rd. arriving at 2255hrs.

CPD Unit 535 – Occupied by UNKNOWN OFFICERS

Unit 535 does not follow the pursuit route.

Unit 535 does not arrive in the area of Heritage Middle School.

CPD Unit 537 – Occupied by Officers Bryant #2256 and Durichko #917

Unit 537 is observed entering the pursuit route from I-90 w/b at e. 72nd St.

Unit 537 shadows the pursuit route arriving at Wymore Ave. and Terrace Rd. at 2256hrs.

CPD Unit 543 – Occupied by UNKNOWN OFFICERS

Unit 543 is observed entering the pursuit route from I 90 w/b at E. 72nd St.

Unit 543 shadows the pursuit route but does not arrive in the area of Heritage Middle School.

Unit 543 travels back to the 5th District Headquarters.

CPD Unit 565 – Occupied by UNKNOWN OFFICERS

Unit 565 is observed entering the pursuit route from East Blvd to Wade Park Blvd.

Unit 565 shadows the pursuit but does not arrive at Heritage Middle School.

Unit 565 travels back to 5th District Headquarters.

CPD Unit 7707 – Occupied by Officer Alan Almeida

Unit 7707 is observed entering the pursuit route S. Marginal Rd. at I-90 e/b.

Unit 7707 follows the pursuit route to Wymore Ave. and Terrace Rd. arriving at 2255hrs.

CPD Unit 9606 – Occupied by UNKNOWN OFFICERS

Unit 9606 is observed following the pursuit route from W. Superior Ave. to Detroit Ave.

Unit 9606 is observed getting off of I-90 e/b at Lakeside Rd. exit 174A.

Unit 9606 does not arrive in the area of Heritage Middle School.

CPD Unit 9608 – Occupied by UNKNOWN OFFICERS

Unit 9608 is observed entering the pursuit route at E. 79th St. and Decker Ave.

Unit 9608 follows the pursuit route to Wade Park Blvd. and East Blvd.

Unit 9608 does not arrive in the area of Heritage Middle School.
