COUNT ONE  
(REPORTING CHILD ABUSE OR NEGLECT)

THE JURORS OF THE SPECIAL GRAND JURY of the State of Ohio, within and for the body of the County aforesaid, on their oaths, in the name and by the authority of the State of Ohio, do find and present that on or about April 12, 2012, at Jefferson County, Ohio, Lynnett Gorman, as a person described in division (A)(1)(b) of Section 2151.421 of the Revised Code, to wit a school teacher; school employee; school authority, who was acting in an official or professional capacity and knew, or had reasonable cause to suspect based on facts that would cause a reasonable person in a similar position to suspect, that a child under eighteen years of age had suffered or faced a threat of suffering any physical or mental wound, injury, disability, or condition of a nature that reasonably indicated abuse or neglect of the child, failed to immediately report that knowledge or reasonable cause to suspect to the entity or persons specified in Section 2151.421 of the Revised Code, in violation of Section 2151.421(A)(1) of the Revised Code, and against the peace and dignity of the State of Ohio, a Misdemeanor of the Fourth Degree.
