Narrative:

On August 16, 2023, SA Holcomb received the EMS run-reports for Austin Huntzinger. Huntzinger was treated by Hamilton Township Fire Department and transported to OhioHealth Grant Hospital. The EMS run-report stated that Huntzinger had multiple gunshot wounds. Medics put Huntzinger on the LUCAS device for CPR. No pulse observed multiple times and CPR was continued for an unknown amount of time and terminated in the hospital.

On Tuesday, August 29, 2023, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Chad Holcomb (SA Holcomb) received Huntzinger's medical records from OhioHealth. The records were obtained pursuant to a court order. The official custodian of medical records at Grant Medical Center, Lori Patterson, stated that there are no medical records for Huntzinger on August 9, 2023.

The Hamilton Township FD run-report and the affidavit from OhioHealth stating there are no records for the date of treatment requested, are attached to this report. Please refer to the attachment for further details.

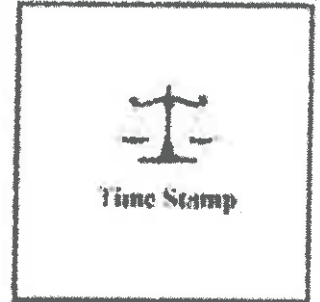

It is further ordered that Ohio Health not notify any person of the existence of this order for 90 days.
