DEAR SIR:—You have inquired as to the status of the title to the hereinafter described premises as disclosed by the abstract submitted which was certified to by Henry B. Grace, abstractor, situate in the township of Franklin, county of Ross, being 400 acres in survey No. 13,441 of the Virginia Military Land, more fully described on the caption page of said abstract and in the deed which are enclosed herewith.

After an examination, it is the opinion of this department that said abstract shows the title to said premises to be in the name of the Second National Bank of St. Clairsville, Ohio, free from encumbrances, excepting the taxes for the year 1922, which constitute a lien.

You have submitted a deed which, in my opinion, is sufficient to convey the interests of the said bank to the state of Ohio when properly delivered.

You have further submitted encumbrance estimate No. 3,328 which contains the certificate of the Director of Finance to the effect that there are unencumbered balances legally appropriated in the sum of twenty-eight hundred dollars (\$2,800) to purchase the said premises.

According to the abstract, no examination has been made in any of the United States Courts.
