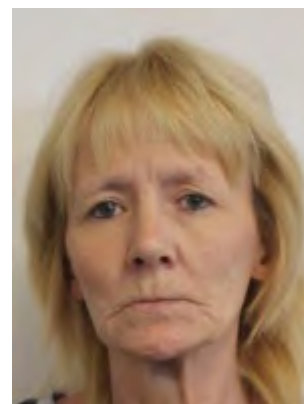

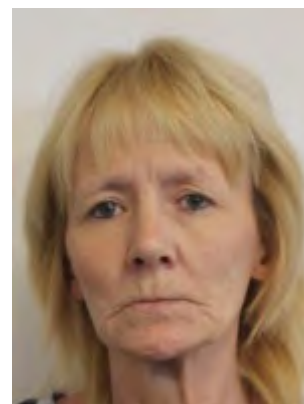

ACTION TAKEN:

On Thursday December 23, 2021 around 0415 hours I, Detective K Williams 1351, responded to 2470 26th Street reference an officer involved shooting.

Upon arrival, Detective M Williams, Taylor, and I performed a brief overview of the scene in the upstairs bedroom. After seeing the scene and speaking with the initial responders we went downstairs to begin the interviews of the witnesses.

I started by interviewing James Greathouse W/M/59, this interview was recorded on my BWC. Greathouse is the brother of Mary Gross. James currently lives at 2470 26th St with his sister, and has a separate room just down the hall from where the incident occurred. Greathouse appears to have a heavy speech impediment and was difficult to understand. The following is a short synopsis of his interview. Greathouse was sleeping in his room when he heard Gross and his sister yelling from down the hall. He heard Gross yell the police would have to kill him before going back to prison, and he was going to kill her too. About the time he got up to see what was going on, Akron Police Officers were already making their way up the stairs. Greathouse believed his sister's live was at risk, and believed Grosses threats to harm her.

After finishing the interview with Greathouse, Lt Hammond and I interviewed Mary Gross.
