APPROVAL, CONTRACT BETWEEN STATE OF OHIO AND JOSEPH WESPISER OF OXFORD, OHIO, FOR THE COMPLETION OF GENERAL CONTRACT FOR CENTRAL UNIT OF CHEMISTRY BUILDING AT MIAMI UNIVERSITY, OXFORD, OHIO, AT AN EXPENDITURE OF \$74,678.00—SURETY BOND EXECUTED BY THE OHIO CASUALTY INSURANCE COMPANY OF HAMILTON, OHIO.

DEAR SIR:—You have submitted for my approval a contract between the State of Ohio, acting by the Department of Public Works, for the Board of Trustees of Miami University, Oxford, Ohio, and Joseph Wespiser of Oxford, Ohio. This contract covers the construction and completion of General Contract Item No. 1, not including mill-work furnished by the state, and not including mechanical trades for a Central Unit of Chemistry Building for Miami University, Oxford, Ohio, according to Item No. 3, Alternate "AB"; Item No. 10; Item No. 12; Item No. 28, Alternate "G-7"; Item No. 25, Alternate "G-6"; Item No. 27, Alternate "G-6AB" of the Form of Proposal dated August 15, 1930. Said contract calls for an expenditure of seventy-four thousand six hundred and seventy-eight dollars (\$74,678.00).

You have submitted the certificate of the Director of Finance to the effect that there are unencumbered balances legally appropriated in a sum sufficient to cover the obligations of the contract. You have also submitted evidence that the consent

of the Controlling Board to the release of funds has been obtained in accordance with Section 2 of House Bill 513 and Section 11 of House Bill 510 of the 88th General Assembly. In addition, you have submitted a contract bond upon which the Ohio Casualty Insurance Company of Hamilton, Ohio, appears as surety, sufficient to cover the amount of the contract.

You have further submitted evidence indicating that plans were properly prepared and approved, notice to bidders was properly given, bids tabulated as required by law and the contract duly awarded. Also it appears that the laws relating to the status of surety companies and the workmen's compensation have been complied with.

Finding said contract and bond in proper legal form, I have this day noted my approval thereon and return the same herewith to you, together with all other data submitted in this connection.

DEAR SIR:—You have submitted for my approval a contract between the State of Ohio, acting by the Department of Public Works for and on behalf of the Board of Trustees of Ohio State University, and George W. Timmons of Columbus, Ohio. This contract covers the construction and completion of General Contract, Items 1-13 inclusive, of the form of proposal dated August 26, 1930, for a caretaker's cottage on Gibraltar Island. Said contract calls for an expenditure of eleven thousand five hundred and fifty (\$11,550.00) dollars.

You have submitted evidence showing that there are sufficient balances from the interest on the endowment fund of the University to cover the obligations of the contract.
