Narrative:

On March 28, 2023, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) John Tingley (Tingley) received a USB flash drive from Brian Adkins (Adkins), the homeowner at 1433 State Route 7, Brookfield Township, Ohio 44403. SA Tingley later provided the USB flash drive to SA Chuck Moran (Moran). The USB flash drive contained home surveillance video files related to the incident and officer-involved shooting that occurred on March 21, 2023, in Brookfield Township.

The USB flash drive contained two folders labeled, “Garage” and “House Driveway.” The “Garage” folder contained 818 video files. The “House Driveway” folder contained 154 video files. SA Moran reviewed the video files and noted the following:

- Garage

The timestamp on the videos appeared to be incorrect. The date was incorrect (behind by one day) and the time was incorrect (behind about one hour).

This camera angle was on the roof of the garage at the residence and faced west (in the direction where the cabin was located and where the incident occurred). It was a long distance away and there was a wooded area obscuring some of the view.
