The first two of the above listed bonds, each in the penal sum of \$10,000, are undoubtedly executed pursuant to sections 1182-2 and 1182-3, General Code, which sections provide in so far as pertinent as follows:

Sec. 1182-2. "The director may appoint additional clerks and stenographers, and such other engineers, inspectors and other employes within the limits of the appropriation as he may deem necessary to fully carry out the provisions of this act; \* \* \*"

Sec. 1182-3. "Each employe or appointee under the provisions of this act, in cases other than where the amount of the bond is herein fixed, may be required to give bond in such sum as the director may determine. All bonds hereinbefore provided for shall be conditioned upon the faithful discharge of the duties of their respective positions and such bonds \* \* \* shall be approved as to the sufficiency of the sureties by the director, and as to legality and form by the attorney general \* \* \*."

Finding these bonds to have been properly executed in accordance with the foregoing statutory provisions, I have endorsed my approval thereon.

The third of the above listed bonds in the penal sum of \$5,000, is evidently executed pursuant to sections 1182 and 1182-3, General Code. Section 1182, General Code, states in so far as pertinent:

"\* \* \* Each division deputy director shall give bond in the sum of five thousand dollars, conditioned for the faithful performance of his duties with sureties to the approval of the state highway director \* \* \*."

Finding this bond to have been properly executed in accordance with sections 1182 and 1182-3, General Code, I have endorsed my approval thereon.

The fourth and fifth of the above listed bonds, each in the penal sum of \$5,000, are undoubtedly executed pursuant to sections 1183 and 1182-3, General Code. Section 1183, General Code, reads in so far as pertinent as follows:

"\* \* \* They (resident district deputy directors) shall \* \* \* give bond in the sum of five thousand dollars. \* \* \*"

Finding such bonds to have been properly executed as provided by sections

1183 and 1182-3, General Code, I have endorsed my approval thereon.

The remaining eighteen of the above listed bonds, each in the penal sum of \$2,000, are undoubtedly executed in accordance with sections 1182-2 and 1182-3, General Code, heretofore quoted.

Finding these bonds to have been properly executed pursuant to these statutory provisions, I have endorsed my approval thereon.

All of said bonds, together with the papers submitted therewith, are herewith returned.
