Narrative:

On January 3, 2022, at 1610 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Chuck Moran (Moran) met with Marquetta Williams (Marquetta) at BCI. SA Moran returned the following evidence items to Marquetta:

- 037, Apple iPhone
- 049, Ohio Direction Card for Marquetta Williams, Netspend Mastercard for Marquetta Williams, Chime Visa Debit Card for Marquetta Williams, Cash App Visa Debit Card for Marquetta Williams and Ohio P-EBT Card for Jae Williams

The cards included in item 049 were removed from James Williams' wallet. SA Moran took photographs of the cards.

SA Moran asked Marquetta if he could take photographs of the text messages and photos on the Apple iPhone belonging to her juvenile daughter to ensure there were no photos, videos or messages about the incident and officer-involved shooting. Marquetta allowed SA Moran to take photographs of the iPhone photos and messages. There were no messages and no photos from the date of the officer-involved shooting.

An evidence receipt was completed and was signed by SA Moran and Marquetta.

SA Moran was previously informed by SA Armstrong that these evidence items could be released to Marquetta per authorization from the Stark County Prosecutor's Office.

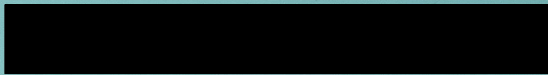
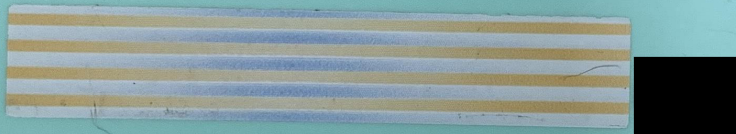
