LEASE—RESERVOIR LAND, STATE TO HATTIE E. McCLANAHAN, DESIGNATED PORTIONS, SHELL BEACH ALLOTMENT, WALNUT TOWNSHIP, FAIRFIELD COUNTY.

COLUMBUS, OHIO, May 9, 1939.

HON. D. G. WATERS, *Conservation Commissioner, Columbus, Ohio.*

DEAR SIR: You have submitted for my examination and approval a certain reservoir land lease in triplicate, executed by the State of Ohio,

through you as Conservation Commissioner to Hattie E. McClanahan of Lancaster, Ohio.

By this lease, which is one for a term of fifteen years of which provides for an annual rent of \$5.00, there is leased and demised to the lessee above named, permission to use and occupy for lawn purposes only, that portion of the State land contained in the easterly portion of Lot No. 1, of Shell Beach Allotment No. 2, being more particularly described as follows: Beginning at an iron pin which marks the southerly-most corner of Lot No. 1; said pin also being at the northwest corner of Lot No. 2; thence in a northeasterly direction on the line between Lots No. 1 and 2, a distance of 113.5 feet to a point; said point being the southeast corner of said Lot No. 1; thence northwesterly along the easterly line of Lot No. 1, a distance of 29.3 feet to an iron pin; thence northerly, 3.1 feet to the northeast corner of said Lot No. 1; said corner being 12 feet southerly from the northeast corner of Lot No. 11, of the original Shell Beach Allotment; thence westerly along the line between Lots Nos. 1 and 11, a distance of 75 feet, being the southwest corner of Lot No. 11; thence in a southwesterly direction across Lot No. 1, a distance of 55 feet, more or less, to the place of beginning, and being in and a part of the Northeast Quarter of Section 23, Town 17, North, Range 18 West, Walnut Township, Fairfield County, Ohio.

Upon examination of this lease, I find that the same has been properly executed by you as Conservation Commissioner and by said lessee. I further find, upon consideration of the provisions of this lease and of the conditions and restrictions therein contained, that the same are in conformity with Section 471, General Code, under the authority of which this lease is executed, and with other statutory enactments relating to leases of this kind.

I am accordingly approving this lease as to legality and form, as is evidenced by my approval endorsed upon the lease and upon the duplicate and triplicate copies thereof, all of which are herewith returned.
