INITIATIVE PETITION

APPROVAL—SUMMARY, PROPOSED LAW TO REPEAL EXISTING STATUTES WHICH PROVIDE THAT SPIRITUOUS LIQUOR IN PACKAGE MAY BE SOLD AND DISTRIBUTED THROUGH STATE LIQUOR CONTROL DEPARTMENT AND STATE LIQUOR STORES, ONLY, AND TO ENACT A LAW TO PROVIDE SUCH LIQUORS SHALL BE SOLD AT RETAIL BY HOLDERS OF PERMITS D-3, D-3a, D-4, D-5 AND D-6.

DEAR SIR: You have submitted for my examination a written petition signed by one hundred qualified electors of this state containing a proposed law and a summary of the same under Section 4785-175, General Code. Copy of said proposed law and a summary of the same are attached hereto. The proposed law repeals the existing statutes which provide that spirituous liquor in the package may only be sold or distributed through the state liquor control department, and state liquor stores and enacts a law which provides that the above mentioned liquors shall be sold at retail by the holders of D-3, D-3a, D-4, D-5 and D-6 permits.

I am of the opinion that the attached summary is a fair and truthful statement of the proposed law and accordingly submit for uses provided by law the following certification:

“Without passing upon the advisability of the adoption of the proposed law and without passing upon the constitutionality of same, but pursuant to the duties imposed upon me under the
