Narrative:

On Wednesday, August 2, 2023, the Ohio Bureau of Criminal Investigation (BCI) was requested by the Ohio State Highway Patrol (OSP) to investigate an Officer-Involved Critical Incident (OICI) that occurred on August 2, 2023, between OSP Troopers and two subjects, Rodney and Elaine Helman.

On August 2, 2023, Special Agent Lauren Frazier interviewed Vandalia Fire Department Paramedic Amanda Everett. The interview was conducted at the Vandalia Fire Department and began at 1241 hours.

Everett stated that she responded to relieve medic units that had been staged on scene. Everett stated that medics were on scene for approximately 20-30 minutes before Ohio State Highway Patrol (OSP) Troopers brought a patient to them via cruiser. The patient was described as the victim, identified as [REDACTED]

Everett stated that [REDACTED] had a gunshot wound (GSW) to his right hand and she began treating him. At this time, she stated medics received a call for assistance, stating that additional units were needed for more gunshot victims. Everett said that once [REDACTED] was stabilized, he was transported to Miami Valley Hospital in Vandalia Medic unit #1. Everett was assisted by Vandalia Paramedic Kyle Smith (driver) and Randolph Carpenter (caregiver). [REDACTED] was transported to Miami Valley Hospital and care was transferred to hospital personnel.

Everett went on to explain that [REDACTED] told him about the incident. She stated that Everett was at a truck stop sleeping when two people broke in. According to Everett, [REDACTED] told the subjects that his truck was broken down. The subjects didn't believe him, got angry, and then shot him in the hand. She was also told that the subjects took 3-4 bottles of his prescribed medication (90 day supply).
