DEAR SIR: You have submitted for my approval a contract by and between L. R. Kennedy, Columbus, Ohio, and the Ohio State University Athletic Board, acting by G. L. Townsend, President, for the Electrical Contract, Item XIII, as set forth in the Specifications for Golf House and Service Building for Ohio State University, dated July, 1937, which contract calls for the total expenditure of one thousand five hundred and sixty-two dollars (\$1,562.00).

You have also submitted a form of proposal for such electrical work, which proposal is properly secured by a bond of the Massachusetts
