**Narrative:**

On August 17, 2023, at about 1330 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Chuck Moran (Moran) met with Trumbull County First Assistant Prosecutor Chris Becker (Becker). SA Moran provided Becker with a 128GB USB flash drive containing the complete BCI case file and all of the BCI case file reference items as of August 17, 2023, for Becker to review.

Becker signed a receipt for the flash drive. A copy of the receipt was attached to this report. SA Moran informed Becker that the Ohio State Highway Patrol (OSHP) had not yet completed a scan and trajectory analysis for the incident. Becker requested SA Moran try to obtain those records from the OSHP and provide them to Becker.

At this time, BCI is awaiting further direction from Becker as to any additional follow-up investigation they may wish and any decisions regarding possible grand jury presentations or prosecutions relative to the incident. SA Moran informed Becker to provide a couple weeks notice if he wanted a PowerPoint presentation created for a possible grand jury hearing.

All evidence in this case is still being stored at BCI. It will be returned to the involved law enforcement agencies when authorized by Becker. Copies of the BCI case file will also be provided to the involved law enforcement agencies when authorized by Becker.

The Matrix case file status was updated to "Referred to Prosecutor."


