When a taxpayer has voluntarily paid moneys into the county treasury in payment of special assessments illegally assessed, which moneys are thereafter received by the municipality, the council of such municipality may by suitable legislation appropriate moneys for the purpose of, and refund such moneys to such taxpayer, as in payment of a moral obligation.
