LEASE—RESERVOIR LAND, STATE WITH BERT VONDERHEIDE, DESIGNATED LAND, LAKE LORAMIE, SHELBY COUNTY.

COLUMBUS, OHIO, July 27, 1939.

HON. D. G. WATERS, *Conservation Commissioner, Columbus, Ohio.*

DEAR SIR: You have submitted for my examination and approval a certain reservoir land lease in triplicate, executed by the State of Ohio, through you as Conservation Commissioner to Bert Vonderheide of Fort Loramie, Ohio.

By this lease, which is one for a term of fifteen years and which provides for an annual rental of \$30.00, there is leased and demised to the lessee above named, permission to occupy and use for residence and agricultural purposes only, that portion of the State reservoir property at Lake Loramie that is described as follows: Beginning at a point in the east line of State highway No. 352, that is 1359 feet north and 657 feet east of the southwest corner of Section 6; said point being the intersection of the north line of the Jeremiah Chambers tract of 14.14 acres and the east line of said highway; thence North 89 degrees 39' east, 682 feet to the northeast corner of the Chambers tract; thence North 0 degrees 01' West, 130 feet, more or less, to the water line of Lake Loramie; thence in a westerly direction following the meanderings of the water line of Lake Loramie, 700 feet, more or less, to the east line of said State High-

way No. 352; thence South 9 degrees 37' West, along the east line of said highway, 366 feet, to the place of beginning, and being in and a part of the Southwest Quarter of Section 6, Town 6 South, Range 5 East, McLean Township, Shelby County, Ohio.

Upon examination of this lease, I find that the same has been properly executed by you as Conservation Commissioner and by said lessee. I further find, upon consideration of the provisions of this lease and of the conditions and restrictions herein contained, that the same are in conformity with Section 471, General Code, under the authority of which this lease is executed, and with other statutory enactments relating to leases of this kind.

I am accordingly approving this lease as to legality and form, as is evidenced by my approval endorsed upon the lease and upon the duplicate and triplicate copies thereof, all of which are herewith returned.

LEASE — RESERVOIR LAND, STATE WITH RUTH WILGUS
AND NINA R. HULL, DESIGNATED LAND, INDIAN LAKE
AND RUSSELLS POINT, LOGAN COUNTY.

DEAR SIR: You have submitted for my examination and approval two reservoir land leases executed by the State of Ohio, through you as Conservation Commissioner to Ruth Wilgus and Nina R. Hull, by which there were leased and demised to the lessees therein named parcels of reservoir lands owned by the State at Indian Lake, Ohio.

The lease executed to Ruth Wilgus of Russells Point, Ohio, which lease is for a term of fifteen years and provides for an annual rental of \$72.00, is for permission to occupy and use for residence purposes cottage and docklanding purposes only that portion of the state reservoir property at Indian Lake known as "Duck Island" or "Brush Island" being in and a part of the northeast quarter of the southwest quarter of Section 36, Township 6 South, Range 8 East, Logan County, Ohio. Also permission to use for automobile parking purposes only a tract twenty-five (25) feet by thirty (30) feet at the west end of the driveway on Island "A" in Indian Lake. Also permission to construct a foot bridge from the said Duck Island to said Island "A" in Indian Lake.
