Narrative:

On March 22, 2023, at 1142 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Chuck Moran (Moran) received an Evidence.com link from Ohio State Highway Patrol (OSHP) Lieutenant (Lt.) Daniel Morrison. The Evidence.com link allowed SA Moran to access the available OSHP body-worn camera (BWC) video files and the available in-car camera (ICC) video file for the incident and officer-involved shooting that occurred on March 21, 2023 in Brookfield Township.

SA Moran downloaded the video files that were provided. The video files were:

SA Moran performed a cursory review of the video files and noted the following:

This video file was 19 minutes and 32 seconds long (19:32). The video file was from a BWC that was attached to OSHP Sergeant (Sgt.) Timothy Grimm (Grimm). The video recording began as officers stood near the roadway at 1433 State Route 7, Brookfield Township, Ohio 44403.

The officers walked along the driveway by the residence (02:37).

The officers quietly walked along the driveway by the garage and camper. A floodlight (possibly motion-activated) illuminated the area (04:55).

Music was heard (likely coming from the truck or cabin) as the officers continued walking along the driveway toward the cabin (07:52).

A loud noise was heard (unknown source) on the audio recording (09:07).

Officers began providing verbal commands and activated their weapon-mounted flashlights as the subject, Fred Wild III (Wild), exited the cabin window and entered the truck (09:23).

The video recorded the incident and the shooting incident. Sgt. Grimm was to the east of the cabin and some distance away from the driver's side of the truck as Wild drove it forward. Sgt. Grimm did not fire his rifle during the incident. A full video review of the incident and shooting incident will be documented in another BCI report.

Officers approached the truck and reported that Wild was not moving (10:03).

Sgt. Grimm and other officers cleared the cabin (10:29).

Sgt. Grimm spoke with OSHP Sgt. [REDACTED] ([REDACTED]). Sgt. [REDACTED] told Sgt. Grimm that he fired during the incident. He said Wild "started coming" and he did not know where the other officers were (10:59).

Sgt. Grimm located a rifle magazine and picked it up from the ground. Trumbull County Sheriff's Office (TCSO) Deputy [REDACTED] ([REDACTED]) said that he lost a magazine. The magazine that Sgt. Grimm picked up belonged to Brookfield Township Police Department (BTPD) Sgt. [REDACTED] ([REDACTED]). Sgt. Grimm handed the magazine to Sgt. [REDACTED] (11:02 through 11:17).

Sgt. Grimm made a phone call (to unknown OSHP personnel) and told them about the incident and how Wild tried to run over the officers and shots were fired. He reported that Wild was deceased. He reported that BWCs were activated during the incident (12:01 through 14:22).

Sgt. [REDACTED] approached Sgt. Grimm and reported that he fired two rounds and he knew he "hit" Wild (14:22). Trooper Brown approached and asked Sgt. Grimm if he fired (14:26). Trooper Brown began collecting all of the firearms that were discharged during the incident.

Sgt. █████ spoke with OSHP Trooper Scott Boyle (Boyle) and described how he moved on top of a pile of brick, saw Wild driving forward, and knew the other officers were behind him and on the passenger side of the truck (15:25).

Sgt. Grimm made another phone call (to unknown OSHP) personnel and told them about the incident and how Wild tried to run over officers with a truck. He reported that shots were fired and Wild was deceased. He reported that Sgt. █████ was the only OSHP personnel to fire. Sgt. █████ asked Sgt. Grimm to ask about turning off his BWC. The unknown OSHP personnel said the BWCs could be turned off (15:53 through 19:32).

Trooper Brown approached Sgt. █████ and said he was going to contact the union about the incident (18:26).

The video recording ended (19:32).

This video file was 22 minutes and 25 seconds long (22:25). The video file was from a BWC that was attached to OSHP Trooper Scott Boyle (Boyle). The video recording began as officers stood near the roadway at 1433 State Route 7, Brookfield Township, Ohio 44403.

The officers walked along the driveway by the residence (02:48).

The officers quietly walked along the driveway by the garage and camper. A floodlight (possibly motion-activated) illuminated the area (04:50).

Music was heard (likely coming from the truck or cabin) as the officers continued walking along the driveway toward the cabin (07:56).

Officers began providing verbal commands and activated their weapon-mounted flashlights as the subject, Fred Wild III (Wild), exited the cabin window and entered the truck (09:20).

The video recorded the incident and the shooting incident. Trooper Boyle was in close proximity to the front driver's side of the truck as Wild drove it forward. Trooper Boyle did not fire his rifle during the incident. A full video review of the incident and shooting incident will be documented in another BCI report.

Officers approached the truck and one of them said that Wild was not moving (09:55).

Trooper Boyle and other officers cleared the cabin (10:35).

Trooper Kevin Brown (Brown) approached Trooper Boyle and asked if he fired. He also asked what happened (11:10).

Trooper Boyle and OSHP Sgt. ██████ provided their rifles to Trooper Brown. Sgt. ██████ asked Trooper Boyle if he fired. Trooper Boyle said he did not fire because he knew there were officers on the other side of the truck (12:25).

Trooper Boyle checked Wild inside the truck and it was clear that he was deceased. Vienna Township Police Department (VTPD) Officer (Ofc.) ██████ (██████) spoke with Trooper Boyle. Ofc. ██████ said he thought Wild was going to run over Trooper Boyle and he remarked about how close Trooper Boyle was to the truck. Trooper Boyle confirmed that he was near the truck (13:24).

Trooper Boyle checked Wild for a pulse and did not locate one (14:03).

Ofc. ██████ said he was behind Trooper Boyle and believed that Wild was going to run him over. Ofc. ██████ held his hands a short distance apart and said, "It looked like you were this close from getting clipped by the plow." Below is an image from Trooper Boyle's BWC (14:24).

Trooper Boyle began collecting the firearms that were discharged during the incident (15:00).

Trooper Boyle spoke with Sgt. [REDACTED] and asked if he fired. Sgt. [REDACTED] confirmed that he fired and described how he moved, how Wild drove the truck, and where the other officers were located (15:07 through 15:30).

Trooper Boyle asked TCSO Sgt. Carr if he fired and Sgt. Carr said he did not fire because he was in a marked cruiser and was going to approach after the cabin was surrounded (17:44).

Sgt. [REDACTED] made a phone call with Sgt. Grimm to OSHP Lieutenant (Lt.) Morrison. Sgt. [REDACTED] confirmed that he fired at the subject from an "elevated position" and he was the first to fire and then other officers fired. It was reported that BCI was responding to the scene (19:49 through 22:10).

Sgt. Grimm told Trooper Boyle that he could turn off his BWC. The video recording ended (22:25).

This video file was 19 minutes and 29 seconds long (19:29). The video file was from a BWC that was attached to OSHP Sgt. [REDACTED] ([REDACTED]). The video recording began as officers stood near the roadway at 1433 State Route 7, Brookfield Township, Ohio 44403.

The officers walked along the driveway by the residence (02:55).

The officers quietly walked along the driveway by the garage and camper. A floodlight (possibly motion-activated) illuminated the area (04:56).

Music was heard (likely coming from the truck or cabin) as the officers continued walking along the driveway toward the cabin (07:51).

A loud noise was heard (unknown source) on the audio recording (09:10) and Sgt. [REDACTED] said, "That's a bad idea."

Officers began providing verbal commands and activated their weapon-mounted flashlights as the subject, Fred Wild III (Wild), exited the cabin window and entered the truck (09:24).

The video recorded the incident and the shooting incident. Sgt. [REDACTED] was in close proximity to the front driver's side of the truck as Wild drove it forward. Sgt. [REDACTED] fired his rifle during the incident. A full video review of the incident and shooting incident will be documented in another BCI report.

Sgt. [REDACTED]'s BWC fell to the ground (09:40).

Sgt. [REDACTED] picked up his BWC from the ground (12:51).

Sgt. [REDACTED] asked if anyone checked Wild for a pulse. Trooper Boyle approached and checked Wild for a pulse (14:02).

Sgt. Grimm asked Sgt. [REDACTED] how many rounds he fired and Sgt. [REDACTED] said he fired two rounds and he knew he "hit him" (14:20).

Trooper Brown began collecting weapons from the officers that fired. Trooper Boyle asked Sgt. [REDACTED] if he fired. Sgt. [REDACTED] confirmed that he fired and described how he moved, how Wild drove the truck, and where the other officers were located (15:00 through 15:30).

Sgt. [REDACTED] spoke with TCO Sgt. Carr. Sgt. [REDACTED] confirmed that he fired and he confirmed that Wild drove in his direction and Sgt. Grimm was behind him (16:59).

Trooper Brown told Sgt. [REDACTED] he was going to contact the union (18:27).

Sgt. Grimm spoke with someone by phone. Sgt. [REDACTED] asked Sgt. Grimm to ask the person if they wanted him to shut off his BWC and the person told Sgt. Grimm to shut off the BWCs. The video recording ended (19:29).

This video file was 17 minutes and 51 seconds long (17:51). The video file was from a BWC that was attached to OSHP Trooper Kevin Brown (Brown). The video recording began as he drove along the driveway to the incident scene near the cabin. The incident and shooting incident occurred before the camera was activated.

Trooper Brown approached the truck that Wild was driving. Wild was in the driver's seat and was clearly deceased (01:53).

Trooper Brown approached OSHP Trooper Boyle and asked if he was alright and about what happened. Trooper Boyle said Wild jumped in the truck and tried leaving. The truck was parked next to the window of the cabin (02:11).

Trooper Brown approached TCSO Deputy [REDACTED] and asked if he was alright and if he fired his weapon. Deputy [REDACTED] possibly responded, "Yeah." OSHP Sgt. [REDACTED] approached and indicated that he fired two times (02:30).

Trooper Brown approached VTPD Ofc. [REDACTED] and asked if he was alright and if he fired his weapon. Ofc. [REDACTED] indicated that he fired his weapon (02:55).

Trooper Brown collected Sgt. [REDACTED]'s rifle and placed it in his cruiser. He placed a second rifle (possibly Trooper Boyle even though he did not fire) in his cruiser, but it was not clear who gave that rifle to Trooper Brown (03:24).

Trooper Brown approached Sgt. [REDACTED] and Sgt. Grimm. He asked Sgt. Grimm if he fired. Ofc. [REDACTED] was observed and heard in the background talking to other officers about how close the snowplow was to Trooper Boyle (05:29).

Trooper Brown escorted the other officers that fired to his cruisers. The other officers placed their rifles in the backseat of his cruiser (06:40).

Deputy [REDACTED] approached Trooper Brown's cruiser and placed his rifle in the backseat (07:40).

Trooper Brown told Sgt. [REDACTED] that he was going to call the union (09:25).

Trooper Brown placed his BWC on his cruiser and said "administrative" (10:13).

Trooper Brown approached Ofc. [REDACTED] and Ofc. [REDACTED] and told them not to say anything to anyone and to contact their union. He also told them not to provide a statement at that time and it was their decision when to provide a statement (15:58).

Trooper Brown spoke with TCSO Sgt. Carr and said he was near the roadway and did not see the incident. He described hearing gunshots and then following Sgt. Carr along the driveway in his cruiser (16:30).

Sgt. Grimm informed Trooper Brown that they were instructed that they did not need to record with the BWCs because the incident was over. The video recording ended (17:51).

This video file was 37 minutes and 29 seconds long (37:29). The video file was from an ICC inside OSHP Trooper Brown's cruiser. The video recording began as he was parked along State Route 7.

Trooper Brown drove along the driveway behind TCSO Sgt. Carr's cruiser and arrived at the incident scene. He parked his cruiser behind Sgt. Carr's cruiser. Trooper Brown exited his cruiser (01:28).

Trooper Brown returned to his cruiser carrying two rifles (03:36).

The video recording ended (37:29).

There was no exterior audio recorded. This video file only recorded audio from inside Trooper Brown's cruiser.

On April 11, 2023, SA Moran received an email from OSHP Lt. Daniel Morrison (Morrison). The email contained audit log details for Sgt. ██████'s BWC, Sgt. Grimm's BWC, Trooper Boyle's BWC, and Trooper Brown's BWC. The audit logs were attached to this report.
