## Narrative:

On Thursday, August 5, 2021, at approximately 1500 hours, Special Agent (SA) Andrew Harasimchuk (Harasimchuk) removed two black shirts (Matrix Item #30), a pair of sweat pants (Matrix Item #39) and a pair of shorts (Matrix Item #41) from the Bureau of Criminal Investigation's (BCI) drying room. These items of evidence had previously been secured in BCI Richfield's drying room on July 29, 2021, at approximately 0330 hours. Refer to SA Harasimchuk's report titled, Evidence Transportation, for further details.

On Thursday, August 5, 2021, at approximately 1500 hours, SA Harasimchuk removed a Sig Sauer P320 firearm, serial number which was loaded with one cartridge in the chamber and a firearms magazine containing five cartridges. There were also two additional firearms magazines, each of which contained 17 cartridges (Matrix Item #37), a Sig Sauer P320 firearm, serial number which was loaded with one cartridge in the chamber and a firearms magazine containing eight cartridges. These items of evidence had previously been secured in BCI Richfield's temporary evidence room, locker #30, on July 29, 2021, at approximately 0330 hours. Refer to SA Harasimchuk's Investigative Report Word 1 (IRW-1) for further details.

SA Harasimchuk and BCI SA Cory Momchilov photographed and examined the abovementioned items of evidence. The two black shirts (Matrix Item #30), pair of sweat pants (Matrix Item #39) and pair of shorts (Matrix Item #41) had bloodlike stains on them. Additionally, the two black shirts (Matrix Item #30) and the pair of shorts (Matrix Item #41) had multiple visible defects on them.

On Thursday, August 5, 2021, at approximately 1600 hours, after the above-mentioned items of evidence had been photographed and examined, the items were secured in BCI Richfield's temporary evidence room, locker #30.
