

Narrative:

On June 29, 2022, Ohio Bureau of Criminal Investigation (BCI) Special Agent Supervisor (SAS) Scott Stranahan complied background information on Quincey Pritchett. Quincey Pritchett, a subject involved in the incident on June 21, 2022 in Lima, Ohio. The information included searching/reviewing criminal history records, court records (if applicable) and open/closed-source database inquiries. The information gather was obtained by the BCI Criminal Intelligence Unit.

SAS Stranahan reviewed the information and noted the following:

# Computerized Criminal History (CCH) and/or Court Records:

### Lima Municipal Court Records:

1. On 8/24/1996, Quincey Pritchett was charged with Resisting Arrest and Persistent Disorderly Conduct. On 10//9/1996, he was convicted of Resisting Arrest and received a 90 day suspended jail sentence, a \$350 fine and one year of probation.

2. On 8/5/1997, Quincey Pritchett was issued a citation for Operators License Required. The docket showed he was sentenced at arraignment and paid costs/fines totaling \$303.00. No other disposition(s) was listed.

3. On 8/15/1997, Quincey Pritchett was issued a citation for Noise/Motor Vehicle in a Public Place. The docket showed he was sentenced at arraignment and paid fines/costs totaling \$155.00. No other disposition(s) was listed.

4. On 9/7/1997, Quincey Pritchett was issued traffic citations for the following offenses: Operators License Required, Stopping After Accident and Red Light. He was also charged with Endangering Children. The dispositions are as follows:

A. Operator's License Required – Found Guilty. No fine. 180 day suspended jail sentence.

B. Stopping After Accident – Dismissed.

C. Red Light – Dismissed.

D. Endangering Children – No fine. 180 day jail sentence.

5. On 9/7/1997, Quincey Pritchett was issued traffic citations for Stopping After Accident, Operators License Required and Reckless Operation on Private Property. The dispositions were listed as follows:

A. Stopping After Accident – Found Guilty. No fine. Sentenced to serve 180 days with credit for 36 days served.

B. Operator's License Required: Dismissed

C. Reckless Operation on Private Property: Dismissed.

6. On 9/7/1997, Quincey Pritchett was charged with Assault and Criminal Damaging/Endangering. The dispositions were listed as follows:

A. Assault: No fine. 180 day jail sentence.

B. Criminal Damaging/Endangering: Dismissed.

7. On December 27, 1999, Quincey Pritchett was issued a citation for Reasonable Control. The docket showed the case was disposed of at arraignment and closed on 3/6/2000. No other disposition(s) was listed.

8. On February 28, 2000, Quincey Pritchett was issued a citation for Noise/Motor Vehicle in a Public Place. The docket showed he received a \$250 fine plus court costs. No other disposition(s) was listed.

9. On February 28, 2002, Quincey Pritchett was issued traffic citations for Driving Under Suspension, Red LIght and Seat Belt. The dispositions are as follows:

A. Driving Under Suspension: \$100 fine plus court costs and 10 days in jail or 80 hours of community service.

B. Red Light: \$25 fine plus court costs.

C. Seat Belt: \$30 Fine.

10. On 7/3/2002, Quincey Pritchett was issued citations for Driving Under Suspension, Speed and Seat Belt. The docket showed he was fount not guilty of these charges.

11. On 1/27/2004, Quincey Pritchett was charged with Domestic Violence. The case was later dismissed.

12. On 11/11/2009, Quincey Pritchett was issued citations for Failure to Reinstate Operator's License and Improper Lane Change. He received the following sentence:

A. Failure to Reinstate: \$500 fine plus court costs, 6 points, a 30 suspended jail sentence with the condition that he perform 100 hours of community service within 6 months

B. Seat Belt: A \$50 fine plus court costs.

13. On 5/29/2012, Quincey Pritchett was issued a citation for a Red Light Violation. At trial, he was found guilty and received a \$50 fine plus court costs.

14. On 4/25/2014, Quincey Pritchett was issued citations for the following offenses: Signals/Change of Course, Marked Lanes and Seat Belt. The docket showed the following dispositions:

A. Signals/Change of Course: Dismissed by the Prosecutor

- B. Marked Lanes: received a \$50 fine plus court costs.
- C. Seat Belt: received a \$30 fine plus court costs.

15. On 5/12/2015, Quincey Pritchett was issued citations for License Plate Violation and Seat Belt. The docket showed he received two fines, one which was listed as \$30 (seatbelt violation). On 8/12/2015, the case was referred to a collections agency. On June 28, 2022, the case was closed due to Quincey Pritchett's death.

16. On 6/28/2015, Quincey Pritchett received a Speeding citation for 82 MPH in a posted 55 MPH zone. He was later found not guilty and the case was dismissed.

17. On 11/22/2016, Quincey Pritchett was issued traffic citations for the following offenses: Stopping After Accident, Driver's View Obstructed and Reasonable Control. The case was later dismissed.

18. On 5/22/2022, Quincey Pritchett was issued traffic citations for the following offenses: OVI, Right of Way (HWY) Stop Signs and Seat Belt. This case was later dismissed due to his death.

## Allen County Clerk of Courts Records:

1. On 10/30/2012, a Certificate of Judgement was filed against Quincey Pritchett for Failure to Pay Personal Taxes. The amount of the judgement was listed as \$318.44. This case is open and has yet to be disposed of.

2. On 8/10/2010, a motion was filed in Allen County Domestic Relations Court documenting that Allen County Child Support Enforcement Agency would maintain jurisdiction over matters pertaining to child support.

## Hancock County Clerk of Courts Records:

No records were located.

## Garfield Heights Municipal Court Records:

1. On 3/10/2022, Quincey Pritchett was charged with Obstruction of Police Business. On March 29, 2022, an arrest warrant for Failure to Appear was issued for this case. No disposition is listed for this case.
