DEAR SIR:—You have submitted for my approval a contract between the State of Ohio, acting by the Department of Public Works, for and on behalf of the Board of Trustees of the Ohio State University, Columbus, Ohio, and The Electric Power Equipment Company of Columbus, Ohio. This contract covers the construction and completion of electrical contract, potting shed for botany, to be constructed on the campus of the Ohio State University, and calls for an expenditure of one hundred and seven dollars. (\$107.00).

You have submitted the certificate of the Director of Finance to the effect that there are unencumbered balances legally appropriated in a sum sufficient to cover the obligations of the contract. The amount of the appropriation from which the above

contractor is to be paid does not exceed five thousand dollars (\$5,000.00), and therefore the consent and approval of the Controlling Board to the expenditure are not required. In addition you have submitted a contract bond, upon which the Globe Indemnity Company appears as surety, sufficient to cover the amount of the contract.

You have further submitted evidence indicating that plans were properly prepared and approved, notice to bidders was properly given, bids tabulated as required by law and the contract duly awarded. Also it appears that the laws relating to the status of surety companies and the workmen's compensation have been complied with.

DEAR SIR:—You have submitted for my approval a contract between the State of Ohio, acting by the Department of Public Works, for and on behalf of the Board of Trustees of the Ohio State University, Columbus, Ohio, and H. J. La Plante, Columbus, Ohio. This contract covers the construction and completion of plumbing contract, small animal building on the campus of the Ohio State University, and calls for an expenditure of four hundred and thirteen dollars (\$413.00).
