- **ONCE THIS SUSPENSION IS IN EFFECT:** Any driver or owner who violates the suspension will have his or her license plates confiscated for at least 30 DAYS first offense and 90 DAYS subsequent offenses. License plates forfeited and sold and the person will not be permitted to register a vehicle until the suspension is lifted.

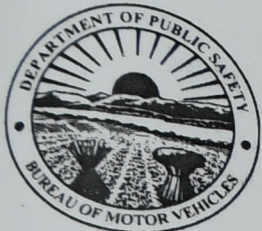
