APPROVAL, ABSTRACT OF TITLE TO LAND OF THE EAST BARBER-
TON LAND COMPANY, SUMMIT COUNTY, OHIO.

DEAR SIR:—You have submitted for my examination and approval an abstract of title and a warranty deed covering a certain parcel of land in Barberton, Summit County, Ohio, and which is more particularly described as follows:

“Being a parcel of land situated in Tract 15, Lot 12, Coventry Township, now in the city of Barberton, Ohio, and beginning at the northwest corner of said lot No. 12; thence south for a distance of nine hundred sixty-six and fifty-seven hundredths (966.57) lineal feet along the center line of Manchester Road to the place of beginning; thence north eighty-nine (89°) degrees thirty-two minutes (32') east for a distance of three hundred forty-four and eighty-seven hundredths (344.87) lineal feet to an iron pipe; thence south for a distance of four hundred ninety and seven hundredths (490.07) lineal feet to an iron pipe; thence south eighty-nine (89°) thirty-two minutes (32') west for a distance of three hundred forty-four and eighty-seven hundredths (344.87) lineal feet to an iron pipe in the center line of Manchester Road; thence north along the center line of Manchester Road for a distance of four hundred ninety and seven hundredths (490.07) lineal feet to the place of beginning, containing three and eighty-eight hundredths (3.88) acres more or less, being a part of a parcel of land containing 48.95 acres.”

The title to this parcel was considered in my opinion No. 91, dated February 14, 1929, addressed to you, in which your attention was directed to certain substantial defects in the chain of title.

You now have submitted a corrected abstract of title certified to by Ray E. Morton, Abstracter, of Barberton, Ohio, under date of March 15, 1929. I am of the opinion that it shows a good and sufficient fee simple title to said parcel of land in The East Barberton Land Company, the grantor in the proposed deed to the State of Ohio, free and clear of all encumbrances save and except the taxes on said parcel for the year 1929, which are a lien against the premises.

Certain sewer assessments which were an encumbrance at the time of my former opinion have now been abated by the council of the city of Barberton through its

ordinance 51-1929, passed March 18, 1929, a copy of which you enclose. Section 1 thereof reads:

“That all assessments for the East Barberton Sanitary Sewer, now due and unpaid or hereafter to become due upon the parcel of land herinafter described, be and the same hereby are abated.”

You have furnished a certified copy of the resolution of the Board of Directors of The East Barberton Land Company, dated November 15, 1928, authorizing the president and secretary of said corporation to execute a warranty deed for said premises to the State of Ohio.

You have submitted a warranty deed from The East Barberton Land Company to the State of Ohio properly executed by the president and secretary thereof, which in my opinion is sufficient to convey the premises to the State of Ohio when properly delivered.

I am returning herewith said abstract of title and deed, together with all other data submitted in connection with the matter.
