DEAR SIR: You have submitted for my approval as to form and legality a contract in duplicate by and between the City of Gallipolis and the State of Ohio, providing for the improvement of State Highway No. 7, Section Gallipolis (part), situated in the city of Gallipolis, Gallia County, Ohio, in accordance with Section 1200, General Code.
