APPROVAL.—RESERVOIR LAND LEASE, STATE OF OHIO, THROUGH CONSERVATION COMMISSIONER, WITH R. C. LICHTY, COLUMBUS, OHIO, TERM FIFTEEN YEARS, ANNUAL RENTAL \$6.00, RIGHT TO OCCUPY AND USE FOR DOCKLANDING PURPOSES, DESCRIBED PORTION, BUCKEYE LAKE, FAIRFIELD COUNTY, OHIO.

DEAR SIR: You have submitted for my examination and approval a certain reservoir land lease in triplicate, executed by the State of Ohio through you as Conservation Commissioner to R. C. Lichty of Columbus, Ohio.

By this lease, which is one for a term of fifteen years and which provides for an annual rental of \$6.00, there is leased and demised to the lessee above named, the right to occupy and use for yard and dock-landing purposes, the waterfront and state land in the rear thereof on the southerly shore of Buckeye Lake, as shown by R. K. Schafley's survey of said lake, that lies in front of Lot No. 12 of Climber's Grand Vire Subdivision of lands located in the Southwest Quarter of Section 27, Town 17, Range 18, and in the northwest Quarter of Section 3, Town 16, Range 18, Walnut Township, Fairfield County, Ohio.

Upon examination of this lease, I find that the same has been properly executed by you as Conservation Commissioner and by said lessee. I further find, upon consideration of the provisions of this lease and of the conditions and restrictions therein contained, that the same are in conformity with Section 471, General Code, under the authority of which this lease is executed, and with other statutory enactments relating to leases of this kind.

I am accordingly approving this lease as to legality and form, as is evidenced by my approval endorsed upon the lease and upon the duplicate and triplicate copies thereof, all of which are herewith returned.
