## APPROVAL, BOND FOR THE FAITHFUL PERFORMANCE OF HIS DUTIES AS CASHIER IN THE BUREAU OF MOTOR VEHICLES—JOSEPH C. FALKENBACH.

HON. JOHN JASTER, JR., *Director of Highways, Columbus, Ohio.*

DEAR SIR:—You have submitted a bond guaranteeing the faithful performance of the duties of Joseph C. Falkenbach as Cashier, Bureau of Motor Vehicles, State of Ohio. Said bond is executed by the Standard Accident Insurance Company of Detroit, Michigan, in the penal sum of ten thousand dollars.

Section 6290-1, General Code, provides in part:

“\* \* \* When in the opinion of the director of highways, it is deemed advisable, any deputy or other employe (of the bureau of motor vehicles) may be required to give bond in such amount and with such security as he may approve. \* \* \*”

Upon examination of the bond, I find same to have been properly executed in accordance with the pertinent statutory provisions, with the exception that the words “and the Standard Accident Insurance Company” should be inserted in the first line of the bond after the words “That we, Joseph C. Falkenbach,”.

Subject to the suggested correction above set forth, said bond is in proper legal form, and is hereby approved as to legal form, and returned herewith.
