Dear Attorney General Yost:

Pursuant to R.C. 3519.01(A), and on behalf of petitioners who seek to propose a constitutional amendment by initiative petition, I am hereby filing two petitions to approve two summaries of a statewide initiative petition titled the Presidential Election Popular Vote Amendment. The two petitions, filed as Petition A and Petition B, contain different summaries of the same proposed constitutional amendment. Petition A, the parts of which have the letter "A" in the top right corner of the cover page, contains approximately 2,475 signatures of electors on approximately 199 part-petitions. Petition B, the parts of which have the letter "B" in the top right corner of the cover page, contains approximately 2,457 signatures of elections on approximately 202 part-petitions. Summaries of the approximate number of part-petitions and signatures are attached to this correspondence.

To the Attorney General of Ohio: Pursuant to Ohio Revised Code § 3519.01(A), the undersigned electors of the State of Ohio, numbering in excess of one thousand, hereby submit to you the full text of a proposed Amendment to the Ohio Constitution and a summary of the same.

TITLE

The Presidential Election Popular Vote Amendment

This Amendment would add Article XX, Section 1 to the Ohio Constitution to:

- Express the will of the People that every vote for President be valued equally and that the candidate who wins the most votes nationally becomes President.
- Require the General Assembly, within sixty days of the Amendment's adoption, take all necessary legislative action so that the winner of the national popular vote is elected President.

This Amendment may result in Ohio Presidential Electors voting for the Presidential candidate who won the national popular vote but not Ohio's popular vote.

FULL TEXT OF PROPOSED AMENDMENT

Be it Resolved by the People of the State of Ohio that the Constitution of Ohio is hereby amended to add Section 1 of a new Article XX to read as follows:

Article XX. Presidential Election

Section 1. Presidential Election Winner

It is the expressed will of the People that every vote for President be valued equally and that the candidate who wins the most votes nationally becomes President. Therefore, the General Assembly shall within sixty days of the adoption of this amendment take all necessary legislative action so that the winner of the national popular vote is elected President.
