In accordance with the provisions of R.C. 3519.01(A), on October 6, 2011, I received a written petition proposing to add an Ohio Alternative Treatment Amendment to the Ohio Constitution, and a summary of the measure to be referred. Pursuant to R.C. 3519.01(A), the Attorney General must examine the summary and determine whether it is a fair and truthful statement of the measure to be referred. If I conclude that the summary is fair and truthful, I must certify that fact to your office within ten days of receiving it. In this instance, the tenth day falls on Sunday, October 16, 2011.
