DEAR SIR: You have submitted for my approval the contract by and between The Ferro Concrete Construction Company, a corporation of Ohio, and The State of Ohio acting through you as Director of the Department of Public Works for the Department of Welfare for the construction and completion of Contract for General Work for a project known as New Kitchen, Central Dining Hall and Cold Storage, Longview State Hospital, Cincinnati, Ohio, as set forth in Item 1, General Contract (exclusive of elevator and dumb-waiter) of the Form of Proposal dated May 11, 1939, all according to Plans and Specifications, which Plans, Specifications and Proposal become a part of this contract. This contract calls for an expenditure of \$126,000.00.
