JECT No. 1, ELECTRICAL CONSTRUCTION, LIBRARY
AND TEACHERS' TRAINING BUILDINGS, COST

DEAR SIR: You have submitted for my approval a contract by and between the Harvey Uhl Electric Company, Akron, Ohio, and the State of Ohio, acting by the Department of Public Works, for the Board of Trustees of Kent State University, Kent, Ohio, for the con-

struction and completion of Project No. 1—Electrical Construction, also wiring and fixtures for present buildings as set forth in Items 1, 2 and 3 Electrical Construction—Underground System as specified and shown on the drawings for Base Bid, Item 4, Alternate 6 (Rewiring the Library Building and furnishing and installing fixtures as called for in the specifications and shown on the drawing and finished complete) and Item 4 Alternate 5-B Rewiring Teachers' Training Building and furnishing and installing fixtures on the basis that each outlet in class rooms is to be wired for 300 watts and equipped with a 300-watt 19 inch "Alsak" aluminum fixture as shown on fixture drawing and specified in fixture schedule and finished complete of the Form of Proposal, which contract calls for the total expenditure of eighteen thousand two hundred and fifty-two and 65/100 dollars (\$18,252.65).

You have also submitted the following papers and documents in this connection: Encumbrance record No. EE-2237, dated August 3, 1938, estimate of cost, division of contract, notice to bidders, proof of publication, workmen's compensation certificate showing the contractor having complied with the laws of Ohio relating to compensation, the form of proposal containing the contract bond signed by the Hartford Accident and Indemnity Company, its power of attorney for the signer, its financial statement and its certificate of compliance with the laws of Ohio relating to surety companies, the recommendations of the State Architect, Board of Trustees, and Director of Public Works, letter of certification from the Auditor of State showing that the necessary papers and documents are on file in said office, controlling board release, and the tabulation of bids received on this project.

Finding said contract and bond in proper legal form, I have this day noted my approval thereon and return the same herewith to you, together with all other documents submitted in this connection.
