DEAR SIR:—You have submitted for my approval a bond in the penal sum of \$5,000, to guarantee the faithful performance of the duties of the official as hereinafter listed:

Clyde E. Haager, Resident District Deputy Director, Fayette County—The New Amsterdam Casualty Company.

Such bond is undoubtedly executed pursuant to the provisions of section 1183, General Code, reading as follows:

“\* \* \* Such resident district deputy directors shall \* \* \* give bond in the sum of five thousand dollars \* \* \*.”

The foregoing section is section 7 of the Norton-Edwards Act of 1927 (112 O. L. 433).

Section 11 of the same act (112 O. L. 435), section 1182-3, General Code, provides in part:

“\* \* \* All bonds hereinafter provided for \* \* \* shall be approved as to the sufficiency of the sureties by the director (of highways), and as to legality and form by the attorney general \* \* \*.”  
(Italics mine).

Since the bond does not appear to have been approved by the Director of Highways, as required by section 1182-3, General Code, supra, I am unable to approve it at this time, and am returning it herewith without my approval endorsed thereon.
