Situate in the State of Ohio, County of Adams, and village of Winchester, and being inlots numbers two (2) and three (3) in said village, as the same are known and designated on the recorded plat thereof.

It is the opinion of this department that said abstracts disclose a good title to said premises to be in the name of Joseph Hughes, free from encumbrances excepting the taxes for the year 1922, which are undetermined but became a lien on April 10th of the present year.

An examination has also been made of the deed that has been submitted, and it is noted that the granting clause of said deed contains the following reservation:

"Saving and reserving unto myself the buildings on the said lots, the same to be moved immediately."

It is believed that said deed is sufficient when properly delivered to convey the interests of the grantor to the State of Ohio, with the exception of the reservation above set forth.
