LEASE—RESERVOIR LAND, STATE WITH ESTELLE W. SHRAKE, DESIGNATED LAND, TURKEYFOOT LAKE, PORTAGE LAKES, SUMMIT COUNTY.

COLUMBUS, OHIO, September 12, 1939.

HON. DON G. WATERS, *Commissioner, Division of Conservation and Natural Resources, Columbus, Ohio.*

DEAR SIR: You have submitted for my examination and approval a certain reservoir land lease in triplicate, executed by the State of Ohio, through you as Commissioner of the Division of Conservation and Natural Resources to Estelle W. Shrake of Canton, Ohio.

By this lease, which is one for a term of fifteen years and which provides for an annual rental of \$12.00, there is leased and demised to the lessee above named, permission to occupy and use for lawn, walkway, docklanding and boathouse purposes only, that portion of the State reservoir property at Turkeyfoot Lake, Portage Lakes, that is described as follows: Being the waterfront and State land in the rear thereof that lies in front of Lot No. 68, Canton Allotment as recorded in Plat Book No. 30, page 39, Summit County records; said lot having a frontage of fifty (50') feet, and being in and a part of Section 13, Franklin Township, Summit County, Ohio.

Upon examination of this lease, I find that the same has been properly executed by you as Commissioner of the Division of Conservation and Natural Resources and by said lessee. I further find, upon consideration of the provisions of this lease and of the conditions and restrictions therein contained, that the same are in conformity with Section 471, General Code, under the authority of which this lease is executed, and with other statutory enactments relating to leases of this kind.

I am accordingly approving this lease as to legality and form, as is

evidenced by my approval endorsed upon the lease and upon the duplicate and triplicate copies thereof, all of which are herewith returned.
